2. One Councilor and one Member elected by the Daman Municipal Council and Daman District Panchayat respectively on rotation basis each year will be notified in due course.
3. The members at Para 1 (f) and 1(g) are appointed for a period of one year.
4. The Chair may invite/co-opt any official members as deemed appropriate or invite any official from any of the Ministries as per requirement. One representative of Ministry of Home Affairs will also attend the meeting.
5. The Convenor of the AAC shall be the Development Commissioner in the UT of Daman & Diu.
6. The Council will meet once in three months. The Ministry of Home Affairs reserves the right to make changes from time to time in the composition of the Council.
