Annexure – I

1. **Name of the Scheme :- Financial Assistance to Boat owner/Fishermen Captured by Pakistan Marine Security Agency (PMSA).**

Objective and Salient feature :

The scheme helps the families of the fishermen/Boat owner who are affected due to captured by Pakistani Marine Security Agency. Ameliorate the hardship due to apprehended/detention of their fishing vessels, by providing one time back ended financial assistance to the fishing vessel owner to reconstruct/replace their fishing vessels.

Pattern of Assistance :

- ₹. 200/- per day to the families of the registered Fishermen having valid ID Cards of U.T. of Daman, Diu and DNH, held captive by Pakistani Marine Security Agency (PMSA).
- One time Financial Assistance in the form of back ended subsidy to the registered boat owner of Daman & Diu to construct/replace their fishing vessels by new fishing vessels @25% maximum up to ₹. 10.00 Lakhs.
- T.A./D.A. to the fishermen during the repatriation from Pakistani Jail :-
 - (i) T. A. 2nd class Sleeper of Railways Fair.
 - (ii) D.A. ₹. 250/- per day/persons.

Annexure – II.

2. **Name of the Scheme :- Financial Assistance to the Fishermen affected by Natural Calamities/Accident etc.**

Objective and Salient feature :

The scheme helps the families of the fishermen who are affected by natural calamities/accident at sea/creek, in case of death/missing (reported till 5 years), snags or death during captivity in Pakistani Jail or One time financial assistance to the boat owners in case of total lose/damage by accident in sea/creek/flood or natural calamity to reconstruct/repair to boat.

Pattern of Assistance :

- ₹. 1,00,000/- one time assistance in case of death would be provided to the legal heir of the fisherman.
- One time Financial Assistance to the boat owners in case of total lost/damage by accident in sea/flood or natural calamity to reconstruct/repair the boat or actual cost, whichever is less :-
 - (i) Trawler/Mechanised boat (15 mtr. and above) ₹. 5.00 Lakhs.
 - (ii) Trawler/ Mechanised boat (below 15 mtr.) ₹. 3.00 Lakhs.
 - (iii) Motorised OBM/IBM (up to 5 mtr.) boats ₹. 1.00 Lakh.

Annexure – III.**3. Assistance to Fishermen for purchase of Fisheries Requisites/Equipments etc.****Objective :-**

This scheme provide Subsidy for purchase of small Fibre Boat, IBM (Diesel driven) Engine, Fishery Requisites such as Fishing Gears and Nets, Oil, Plastic Floats, Nylon Twines, Diesel Canes, Winches, Wireless/Walki-Talki, Electronic Equipments, Insulated Ice Boxes, Onboard FRP Fish Hold/Cold Room of FRP Sheets and Transport Equipment etc.

Pattern of Assistance if any :-

Loan : Loan to be obtained from Banks/any financial institution or borne by the beneficiary.
