Bhimpore, District Daman as legal heirs and two married daughters namely Neetaben Dahyabhai and Niharika Kiranbhai. That the said deceased Gajanan alias Gijubhai Bhulabhai died without will or any other testamentary disposition of his last wishes but leaving some movable properties including deposit/Savings in HDFC Bank Ltd. and post and immovable properties i.e. lands in Village Bhimpore, District Daman and lands at Village Kalsar, Taluka Pardi, District Valsad under Khata No. 388. That as per law prevailing in District Daman applicable to Non Christian inhabitant of Daman, His widow Shantaben Gijubhai Patel usufructury right in the Estate of deceased Gajanan alias Gijubhai Bhulabhai Patel and Except his said two sons (one) Ketankumar Gijubhai Patel and (two) Harishkumar Gijubhai Patel, who are now only legal heirs and successor and said deceased, there does not Exist any other person or persons according to the law of Succession i.e. code of the customs and usages of the Non Christian inhabitants of Daman in force in the District of Daman as applicable to the said deceased being such non Christian Inhabitant of Daman, who may have a right of Succession or may put in a claim to the inheritance and Estate of the said deceased. That by the present deed, the declarants do hereby affirm and state for all legal purpose that the above mentioned Shantaben Gijubhai Patel having the life time Estate, in other words, widow's Estate and two sons named above are the only legal heirs and successors of the above deceased Gajanan Alias Gijubhai Bhulabhai Patel, and there is no other person, who as per prevailing law, may be preferred to them who may have better claims to the Estate left by the deceased Gajanan alias Gijubhai Bhulabhai Patel.
