ORDER

Whereas, the General Election for wards of District Panchayat, Daman was held on 05.10.2015, and the Election Commission for UTs has published the results of General Election vide Notification No. 7-2/EC/DD/2015 dated 06/10/2015 in Extraordinary Official Gazette of UT of Daman & Diu vide No. 58 dated 6/10/2015.

Now, therefore the Administrator of Daman & Diu in terms of Section 60(1) of the Daman & Diu Panchayat Regulation, 2012 fixes **13th October, 2015** as the date when the first meeting of the District Panchayat, Daman be convened for taking **Oath of office** by each of the Member before Secretary Panchayat.

Further, Secretary Panchayat of Daman & Diu in terms of Section 61 of the Daman and Diu Panchayat Regulation, 2012 fixes 13th October, 2015 as the date and appoints Shri R. C. Meena, Deputy Collector (HQ), Daman as the Officer to call the meeting of elected members of the District Panchayat, Daman, to elect from amongst themselves, a President and a Vice-President.

The Oath of Office shall be taken by each elected member before the officers as specified above, in the form set out in the First Schedule of the Daman and Diu Panchayat Regulation, 2012.
