- (d) **The Village Health and Sanitation Committee (VHNSC)** shall be expanded by including a school-teacher, preferably a lady teacher located in respective village area and a peer educator in UT of Daman & Diu.

The above committees of UT of Daman & Diu will be responsible for specific intervention and coordination of the activities under Rashtriya Kishor Swasthya Karyakram (RKSK) in the UT of Daman & Diu.

2. The Administrator, UT of Daman and Diu is further please to :

- (a) Designate State Programme Officer/Director Medical and Health Services as State Nodal Officer of RKSK/Adolescent Health for UT of Daman & Diu.
