The Administrator of UT of Daman and Diu is hereby pleased to re-constitute a Committee of Slaughter House for the UT of Daman and Diu as directed by the Hon. Supreme Court of India vide order referred to in the preamble above, consisting of following officials and non-official members :

The functions of the Committee are as under :

- (i) To identify and prepare a list of all the slaughter houses (SHs) located within the local self Govt. (Municipal area, Panchayats etc.)
- (ii) To call for reports from the District Magistrate or the Deputy Commissioner and District Food Safety Inspector as the case may be, on the condition/functioning of SHs and also on the compliance of the relevant applicable laws.
- (iii) To recommend modernization of old slaughter houses and to re-locate SHs which are located within or in close proximity of a residential area.
- (iv) To recommend appropriate measures for dealing with solid waste, water/air pollution and for preventing cruelty to the animals meant for slaughter.
- (v) To carry out surprise and random inspection of SHs regularly and to issue directions for compliances of the recommendations that may be made by it to send bi-annual reports on the State SHs to the Central Committee and to refer issues that may be require Central Committee's recommendations or Central Govt. assistance.
- (vi) To accord final approval for licensing of SHs to local self Govt.
- (vii) To identify on an on going bases, the unlicensed slaughter houses in the region, and other unlicensed, unlawful establishment where animals are being slaughtered, on howsoever a small scale, and take the help of the District Magistrate and other law enforcement agencies to crack down on the same.
- (viii) To check for child labour.

This order shall supersede the earlier order dated 17.10.2012.

The powers shall be exercised subject to availability of specific budget provisions and due observance of the provisions of General Financial Rules 2005, Delegation of Financial Powers Rules, 1978, CPWD Manual/Code/Daman & Diu Municipal (Amended) Regulation, 1994, Municipal Account Code and other orders/instructions/circulars/directions, etc. issued by Government of India and UTs Administration from time to time.
- b. The proposal exceeding the above financial limit shall be submitted to Administrator, UT of Daman & Diu.
