**Terms of Reference of RRT in Prevention and Control of Communicable Diseases are as under :**

1. Surveillance of Outbreaks and risk analysis in the District/UT.
2. Establishing clear lines of responsibility for planned actions.
3. Conducting regular meetings to review data and evaluate the effectiveness of the implemented measures in the District/UT.
4. Predicting and planning for potential future outbreaks in the District/UT.
5. Determining additional resources needed for rapid response.
6. Ensuring availability of personnel and training.
7. Maintaining an inventory of resources for rapid response.
8. Conducting regular simulation exercises and training in the District/UT.
9. Making recommendations for improvements of outbreak preparedness plan.
10. Coordinating & deployment of resources.
11. Maintaining an archive of outbreak management reports.

The above committee will carry out the surveillance activity for the events related to Outbreaks of **Vector borne, Water borne and air borne diseases** in UT of Daman & Diu.
