NOTIFICATION

A Coastal Police Station at Moti Daman is functioning within the jurisdiction of Daman District of the Union Territory of Daman & Diu as per notification No.1/92/2006-Home/611 dated 10/10/2006.

2. In exercise of power conferred by clause(s) of section 2 of the Code of Criminal Procedure, 1973 (No.2 of 1974) the Administrator of U.T. of Daman & Diu is pleased to extend the jurisdiction of Coastal Police Station at Moti Daman up to the territorial waters in Arabian Sea that is up to 12 Nautical Miles from the Coast Line to include the area bound within (A) Kalai River (Jampore) 20° 22'N 72° 49'E, (B) Coordinates 20° 22'N 72° 37'E, (C) Coordinate 20° 22'N 72° 39'E and (D) Kolak River (Kadaiya) 20° 27'N 72° 51'E as represented schematically in map attached.

3. The functions of the above said Coastal Police Station, Moti Daman will be as follows:

- i) The Police force will exercise all Police Powers conferred on them under Cr. P. C, IPC, the Evidence Act, 1972, and various other associated laws/acts enforced for the time being to register, enquire, investigate, apprehended and prosecute persons engaged in any crime at the water front/sea limits
- ii) To collect intelligence about the anti social elements/water front criminals/smugglers and to disseminate, share and co-ordinate with Indian Navy, Indian Coast Guard, Port, Customs, Fisheries and neighboring Police Stations to prevent and detect unlawful activities in the Coastal areas and territorial waters.
- iii) To patrol the water front area, provide protection to the Coastal stretch, Port/Fishing harbor to combat the menace of sea borne terrorism and prevent of intrusion in our territorial waters.

Contd.....

- iv) To check the infiltration of anti social elements into our territory and territorial waters.
- v) To patrol coastal waters in order to prevent the fishing dispute which often erupt off the coast among various fisherman groups of Daman and adjoining area of Daman.
- vi) To conduct random checking of vessels so as to prevent Human Trafficking, smuggling of marine products, contraband or any other item banned by the Government from time to time.
- vii) To organizing, search, salvage, rescue operation whenever the need arises as well as during natural calamities and to accord assistance in disaster Management.
- viii) To preventing movement and harboring of unauthorized/unlicensed vessels and boats in the Coastal area, Port and fishing harbors.
- ix) To perform Coastal Security Exercise when called for, in co-ordination with other coastal agencies viz. Indian Navy, Indian Coast Guard, Port, Customs, Fisheries Department & Police (Law and order agency)
- x) To conduct sea surveillance during the visit of protected persons as directed from time to time by competent authority.
- xi) To take such steps/measures as are necessary to prevent mischief, sabotage, pilferage in the port/fishing harbor areas.
- xii) To check and keep watch over the unauthorized use of communication/security equipments issued to the fisherman.

In exercise of the powers vested on him, the Administrator of Daman & Diu and Dadra & Nagar Haveli is hereby pleased to amend the following eligibility criteria, conditions to allot the Govt. Land for Shrimp Farming / aquaculture at Daman & Diu.

Contd.....

(1) Lease Period :

The land will be allotted to individual beneficiary initially for a period of Ten years and may be extended for further period of Ten Years, if lessee satisfies all terms & conditions of lease agreement.

(2) Rate of Lease Rent :

Lease Rent of Rs. 18,000/- per hectare per year for first ten years and for next ten years increase by 25% or as decided by the U.T. Administration of Daman & Diu.

(3) Eligibility Criteria for allotment :

1. Applicant shall not be below 18 years of age and not more than 60 years of age as on 1st January 2015
2. The applicants should be Indian Citizen and resident of U.T. of Daman & Diu (Domicile certificate to be produced).
3. Applicant who has undergone shrimp farming training individually either with MPEDA/State Fisheries Department or trained & qualified candidates will be given priority.
4. The applicant and/or his /her family member, who have already obtained Govt. land on lease for shrimp farming or any other purpose, shall not be eligible.
5. A person having one or more fishing boat or ice plant shall not be considered eligible, as the process is for employment generation.
6. A person working in Govt. on permanent basis shall not be considered eligible for allotment of Govt. land on lease basis for shrimp farming.
7. Reservation shall be observed for allotment of land for widow-10%, Physically Handicapped-1%, local villagers (Bucharwada & Zolawadi)-20% (10% for each Village) and remaining for OBC/ SC/ ST/Others.

(4) Area of Land to be allotted :

Each Unit/farm consisting of 3.00 hectares of land area shall be allotted on lease basis, with equal sharing of the land area, between two eligible applicants.

(5) Empowered Committee for Selection :

District level Committee consist of following members as per Notification No.SFD/3/31(Fish-Farming)/2012-13/1308 dated 03/01/2013 :

(6) Powers for Land allotment

District Collector is empowered to allot the Govt. land up to 5 Ha. only for the purpose of Shrimp farming on the basis of recommendation of the District Level Committee.

(7) Terms & Conditions

1. Each unit having land area maximum 3.00 hectares will be allotted on annual lease basis to the eligible applicants (2 Nos.), each having equal share of land for shrimp/aquaculture. Farm shall be constructed leaving a distance of 100 mts. from creek as per the Master Plan prepared by the Marine Products Export Development Authority, Valsad.
2. Applicant has to strictly follow directions of the Coastal Aquaculture Authority, Chennai and District Level & U.T. Level Committee for development of fish farming and allied activities and obtain a license from the Coastal Aquaculture Authority of India for shrimp farming within a period of six months.
3. The applicants have to incur expenditure for development of common facilities such as feeder canal, drainage channel, common passage, peripheral dyke towards creek side etc. About 100 mts. distance from creek channel should be left for common passage for movement of local people/ traditional fishermen towards creek side.
4. The construction of ponds should be completed within six months period after final allotment of land on lease basis and has to take one crop thereafter; otherwise Lease land will be revoked without giving any notice.
5. The leasee shall bear all necessary expenditure in the matter.
6. During the tenure of lease period, in the case the lease holder passes away, the lease right shall be transferred to the legal heirs of the lessee and Govt. will consider further to extend the lease period to the legal heirs after the completion of the tenure.

In exercise of the powers condferred by sub-section (3) of section 34 of the Indian Boilers Act, 1923 (V of 1923), the Administrator of Daman & Diu and Dadra & Nagar Haveli hereby excludes the boiler and the steam pipes or stem pipe in the whole of the U.T.'s of Daman & Diu and Dadra & Nagar Haveli from the operaton of the provisions of sub-sections (2), (3) and (5) of section 7, sub-section (5) of section 8 and section 12 and section 13 of the said Act, subject to the conditions and restrictions specified in the Schedule appended to this notification.

SCHEDULE

- (a) The Boiler and the Steam pipes or Stem pipe shall be inspected every year by the owner as per the technical provisions of the Indian Boiler Regulations, 1950, by any of the following agencies hereinafter called as Third Party Inspection Agencies, namely :-

- (b) The Third Party Inspection Agency shall follow instructions and guidelines of the Chief Inspector of Boilers and shall be liable and responsible for any act of omission or commission committed against the provisions of the said Act and Rules and Regulations framed thereunder.
- (c) The Third Party Inspection Agency shall submit records of inspections carried out by them to the Boiler Inspector, Chief Boiler inspector and Boiler Owner within thirty days of carrying out the inspectin and preferably also on their web-site. It is clarified that on receipt of inspection report by the Boiler Inspector, the inspection report will be duly pasted in the Memorandum of Inspection Book by the concerned Boiler Inspector. It is further clarified that inspection by Third Party Inspection Agencies is optional.
- (d) Report of daily chemical analysis for feed water and blow down water should be submitted monthly to the Third Party Isnpection Agency as mentioned in para (a) for scrutiny and Chief Inspector of Boilers for information.
- (e) Working pressure of the boiler shall not exceed that as specified in the last working certificate issued.

- (f) The Boiler shall be stopped immediately, if any accident occurs to the boiler or to any part of the boiler during this period and the Chief Inspector of Boilers shall be informed immediately.
- (g) The Boiler shall be attended by qualified Boiler Attendants(s).
- (h) This notification will be applicable to such Boilers and stem pipes or stem pipe having the safe guard system like protection against over pressure, low water level, flame failure etc. for prevention of accidents of boilers and provision of these safe guards shall have to be certified by the owner and the third party inspector.
