No. 4/05/DMC/NOTI/DMN/2015-16/428 Whereas, the last General Election to the Daman Municipal Council was held on 23rd January, 2011, and the duration of five years of the said council from the date appointed for its first meeting i.e. 03.02.2011 is due to expire shortly.

Whereas, Rule 22 of the Daman and Diu Municipalities (Elections) Rules, 1995, provides, inter alia, that "a general election shall be held for the purpose of constituting a new council on the expiration of its duration."

Whereas, the Election Commission appointed under Article 243-L of the Constitution of India and Section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994 (No. 1 of 1994) and as referred in Section 5 of the Daman and Diu Municipalities (Amendment) Regulation, 1994, has recommended that the Administrator of the Union Territory of Daman and Diu may be pleased to call upon, by a notification to be published in the Official Gazette on 6th January, 2016 all the wards of Daman Municipal Council in the Union Territory of Daman and Diu to elect members for the purpose of constituting new council in the Daman through poll on 30th January, 2016 being the date of poll, and to complete the process of election by 2nd February, 2016.

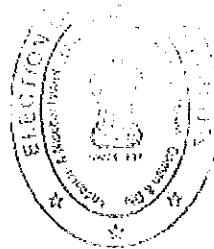

No. 7-14/EC/DD/2015: Whereas, the Administrator of the Union territory of Daman and Diu has, by notification under Rule 23 of the Daman and Diu Municipalities (Elections) Rules, 1995, published in the Official Gazette on the 6th January, 2016, called upon all wards of the Daman Municipal Council to elect members to constitute a new Municipal Council;

Now, therefore, in pursuance of the provisions of Rule 28 of the Daman and Diu Municipalities (Elections) Rules, 1995, the Election Commission for the Union territory of Daman and Diu, appointed under Section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994, hereby appoints the following dates for the said election:-
