ORDER

WHEREAS, the S.S.C. and H.S.C. Examination, 2016 are scheduled to be held in Diu from 08-03-2016 to 22-03-2016 between 10:00 to 2:00 & 2:30 p.m. to 6:00 p.m. as per the Examination Time – Table declared by the Gujarat Secondary & Higher Secondary Education Board, Gandhinagar (Gujarat).

AND WHEREAS, the following schools have been declared as the Centre of examination :-

- i) Government Higher Secondary School, near Fort, Diu.
- ii) Govt. High School (Girls), Main Bazar, Diu.
- iii) Govt. Higher Secondary School (Girls), Near Panjarapore, Ghoghla and
- iv) Govt. Higher Secondary School, Near Tad Check-Post, Bucharwada.

AND WHEREAS, there is a likelihood of a number of people gathering around these examination Centres and there is a possibility of disturbance of peace and public tranquillity which may hamper the smooth conduct of the examination.

AND WHEREAS, I am satisfied that there are sufficient grounds for proceeding under Section 144 of the Code of Criminal Procedure, 1973 and that circumstances do not admit of serving notices individually.

NOW, THEREFORE, in exercise of the powers conferred to me under Section 144 of the Code of Criminal Procedure, 1973 (No. 2 of 1974), I, **VIKRAM SINGH MALIK**, the District Magistrate, Diu do hereby prohibit :-

- (1) Gathering of Public in general/individual for carrying out any illegal activity in and around the area of 100 meters of the Centres specified for the **S.S.C. & H.S.C. Examination.**
- (2) Carrying of Licensed/unlicensed arms and ammunitions or sharp weapons of offenses, sticks or lathi, Swords, daggers, cudgels, spears bludgeons, knives or any kind of other articles which is capable of being used for causing physical injury in Public place or otherwise during the period of **S.S.C. & H.S.C. Examination.**
- (3) Use of loudspeakers or static loudspeakers or sound producing instruments within a radius of 200 meters of the Centers specified for the **S.S.C. & H.S.C. Examination.**

And further direct that restrictions herein above, shall not apply to :-

- i) The Officers/Officials on duties in their respective Offices situated within the premises of the Administration concerned with the maintenance of Law & Order in Diu District.
- ii) The Police Officers/Police personnel employed/deployed on their respective duties around the areas of the Centres specified for **S.S.C. & H.S.C. Examination.**
- iii) The Government Servants of the Administration on duties in their respective offices situated within the premises.
- iv) Any other person duly authorized in writing by the District Magistrate for the particular purpose or meeting of any perils.
- v) The Tourist coming from the other states.

This order shall remain in force from 08-03-2016 to 22-03-2016 between 09:30 a.m. to 6:00 p.m. daily.
