In partial modification of the Notification No. DDTTr./DMN/TRAFFIC-(PART)/14-15/684 dated 16/12/2015 and in exercise of the powers conferred by the provisions of Section 115 of the Motor Vehicles Act, 1988 and Notification No. ADTr./Traffic/Misc-42/2012-13/403 dated 23/10/2012, I hereby restrict driving of all kind of motor vehicles on the roads shown in the column (2) of the Schedule below in the interest of public safety and convenience.

Road Starting from Teen Rasta heading towards Southern Side Fort Gate, Moti Daman	<b><u>NO ENTRY FOR ALL KIND OF VEHICLES</u></b> <b>MONDAY TO FRIDAY : 1.00 PM TO 2.00 PM</b> Note : The vehicle going from Foot Ball Ground side to Fort area, after the bridge, shall <b>compulsory take left turn</b> and be diverted through the link road along the Fort and use Northern side Fort Gate for their entry into Fort Area.
2.	Road Starting from Norther Side Fort Gate to Jetty, Moti Daman	<b><u>NO ENTRY FOR ALL KIND OF VEHICLES</u></b> <b>MONDAY TO FRIDAY : 1.00 PM TO 2.00 PM</b> Note : The vehicle going from Fort Area towards the Foot Ball Ground Side, Moti Daman shall use Southern Side Fort Gate for their exit.

Further, in exercise of the powers under Section 116 of the Motor Vehicles Act, 1988, I hereby authorize Executive Engineer, PWD, Daman for the erection of Traffic Sign Boards mentioned above for the purpose of regulating motor vehicular traffic.

This notification shall come into force with immediate effect.
