सा.का.नि. 224.—राष्ट्रपति, संविधान के अनुच्छेद 309 के अन्तर्गत शक्तियों का प्रयोग करते हुए, दमण एवं दीव भर्ती (अभियोजन निदेशक) 2013, नियम में संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:—

1. (1) इन नियमों का संक्षिप्त नाम दमण एवं दीव (अभियोजन निदेशक) (संशोधन) भर्ती नियम, 2015 है।

(2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।

2. दमण एवं दीव भर्ती (अभियोजन निदेशक) 2013, नियम की अनुमूची में,

(i) स्तंभ (9) की विद्यमान प्रविष्टियों के स्थान पर निम्नलिखित प्रविष्टियां रखी जाएंगी, अर्थात्:—

“लाम् नहीं होता, तथापि, समूह “ख” पद से समूह “क” पद पर पदेनत अधिकारियों के लिए दो वर्ष।”

(ii) स्तंभ (11) में, पदेनति शीर्ष के अधीन “नोट 3” का लोप किया जाएगा।

G.S.R. 224.—In exercise of the powers conferred by the proviso to article 309 of the Constitution the President hereby makes the following rule to amend the Daman and Diu (Directorate of Prosecution) Recruitment Rules, 2013 namely:-

1. (i) These rules may be called the Daman and Diu (Directorate of Prosecution) Amendment Recruitment Rules, 2015.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the Daman and Diu (Directorate of Prosecution) Recruitment Rules, 2013:

(i) in Column 9 for the existing entries the following shall be substituted namely, “Not applicable. However, two years for officers being promoted from Group “B” posts to Group “A”.”

(ii) in Column 11 for promotion, “Note 3” shall be omitted.
