WHEREAS, vide Notification No. FSSA/DD/DMN-GUTKHA/2014-15/223 dated 22/04/2015, the manufacture, storage, distribution or sale of Gutkha and Pan Masala, containing either tobacco and/or nicotine or Magnesium Carbonate as an ingredient, by whatsoever name these are available in the market and any other products marketed separately to constitute as Gutkha or Pan Masala, etc. as final product, was prohibited by the Commissioner Food Safety, UT of Daman and Diu, in exercise of power conferred by clause (a) of sub-section (2) of Section 30 of the Food Safety and Standards Act, 2006 (Act No. 34 of 2006), for a period of one year w.e.f. May, 1, 2015.

AND WHEREAS it is expedient in the interest of public health to extend the period of above prohibition beyond the period covered by the notification referred to above.

NOW, THEREFORE I, the Commissioner of Food Safety, UT of Daman and Diu, in exercise of the powers conferred by clause (a) of sub-section (2) Section 30 of the Food Safety and Standards Act, 2006 (Act No. 34 of 2006), in the interest of public health, hereby prohibit the manufacture, storage, distribution or sale of Gutkha and Pan Masala, containing either tobacco and/or nicotine or Magnesium Carbonate as an ingredient, by whatsoever name these are available in the market and any other products marketed separately to constitute as Gutkha or Pan Masala, etc. as final product, are hereby prohibited in the whole UT of Daman and Diu, extended for a further period of one year with effect from May 1, 2016.

In exercise of the powers conferred by the provision to Article 309 of the Constitution, read with the Department of Personnel and Training O.M. No. AB.14017/48/2010-Estt.(RR) dated 31/12/2010, the Administrator of Daman & Diu is pleased to makes the following Rules relating to recruitment to the General Central Service Group "C" (Non-Gazetted, Non-Ministerial) posts of **Workshop Instructor** in the Government Polytechnic, Daman under the Directorate of Technical Education in the Administration of Daman and Diu, namely :

**1. SHORT TITLE, APPLICATION AND COMMENCEMENT :**

- (i) These rules may be called by the Administrator of Daman and Diu, Workshop Instructor, Group "C" Non-Gazetted, Non Ministerial post Recruitment Rules, 2016.
- (ii) They shall apply to the post specified in column No. 1 of the schedule to these Rules.
- (iii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the specified in Column No. 2.

**2. NUMBER OF POSTS, CLASSIFICATION AND SACLE OF PAY :**

The number of posts, classification of the said posts and the scales of pay attached thereto shall be as specified in Columns No. 2 to 4 of the Schedule to these rules: Provided that, the Administrator of Daman & Diu may vary the number of post in column No. 2 of the said Schedule from time to time subject to exigencies of work.



**3. METHOD OF RECRUITMENT, AGE LIMIT AND OTHER QUALIFICATIONS :**

The method of recruitment to the said posts, age limits, qualifications and other matters connected therewith shall be as specified in columns No. 6 to 13 of the aforesaid Schedule.

**4. DISQUALIFICATION :**

No Person (a) Who has entered into or contracted a marriage with a person having a spouse living, or (b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the service Provided that, the Administrator of Daman and Diu may, if satisfied that such marriage is permissible under the personnel law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

**5. POWER TO RELAX :**

Where the Administrator of Daman & Diu is of the opinion, that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provision of these rules with respect to any class or category of persons.

**6. SAVINGS :**

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
