NOTIFICATION

In exercise of powers conferred by section 35 of the Goa, Daman and Diu Fire Force Act, 1986 (Act No. 9 of 1986), the Administrator of Union Territory of Daman and Diu is pleased to make the following amendment in Appendix VII appended to the Daman and Diu Fire Force Rules, 2004 vide Notification No. DFS/DD/F.S. Rules/2004/366 dated 04-10-2004, as follows, namely :-

1. Short title and commencement –

- (1) These Rules may be called the Daman and Diu Fire Force (4th Amendment) Rules, 2016.
- (2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment in Appendix VII :

- (i) Sr. No. 01 to 05 of Appendix VII appended under rule 26 of the Daman and Diu Fire Force Rules, 2004 shall be amended as per the approved annexure.

APPENDIX – VII

Rates to be charged for services of all types with in or outside the Union Territory.

Sr. No.	Description	Charges
1.	Pumping job	Fees for pumping job appliances shall be Rs. 500/- per hour or part thereof and distance covered from station and back @ Rs. 50/- per Km.
2.	Hiring fire fighting equipment/ appliance	Fees for hiring fire fighting equipment or an appliance shall be Rs. 500/- per hour or part thereof and distance covered from station and back @ Rs. 50/- per Km.
3.	Stand-by charges for appliances	Fees shall be Rs. 700/- per hour or part thereof and distance covered from station and back @ Rs. 50/- per Km.
4.	Attending calls outside the Union Territory	(a) Each appliance turned out shall receive Rs. 2000 per call and Rs. 50/- per Km. of the distance covered from station and back. (b) Pumping fees per hour shall be Rs. 500/- or part thereof. (c) Other materials charges shall be determined by the Director.
5.	Charges for imparting training on basic fire safety.	Fees shall be Rs. 100/- per employee.

6.	No Objection Certificate (Fire NOC/Report) charges for :-	
(a)	Restaurants, Bakeries, Eating houses where the seating capacity does not exceed 25 persons.	Rs. 500/- per NOC per annum.
(b)	Licensed Fireworks shop less than 50 pounds, Saw Mills, Non-dangerous Petroleum less than 5000 kgs. and LPG/ING less than 100 kgs.	Rs. 500/- per occupancy per annum.
(c)	(i) Buildings over 15 meters in height.	Rs. 10/- per square meter built up area of the occupancy.
	(ii) Residential-cum-Commercial, Commercial buildings below 15 meters in height.	
	(iii) Industrial units & Establishment where electric motor capacity exceed 05 HP and above	
	(iv) Shipyard and workshop.	
	(v) Tank Farms or Petroleum products/P.O.L. dispensing outlets.	
	(vi) Flammable Gas Godown/ LPG Gas Godown.	
	(vii) Godown and warehouses	
	(viii) Public places like exhibition halls, Entertainment places, dancing halls, Theatres, Assembly halls, Sea port, Airport, Railway Stations, Bus Stations, Stadia etc.	
	(ix) Educational and Institutional places.	
	(x) Hotels, Restaurants, where seating / lodging capacity exceeds 25 persons.

	(xi) Storage of places of hazardous and flammable goods.	
(d)	Renewal of Fire NOC/Report of all occupancies.	Rs. 2500/- per occupancy per annum.

Note :

- (1) The above fee at Sr. No. 01 to 03 and 05 shall be payable in advance by the applicant.
- (2) The fee referred at Sr. No. 04 of the above rule shall be payable within one month of the service of notice of demand by the department on the owner or occupier and if it not paid within that period, it shall be recoverable as an arrear of land revenue with simple interest of 2% per month.
- (3) The fee at the rate of ten rupees per square meter of the built up area shall be payable by the owner of various occupancies along with the applications submitted to the Assistant Divisional Officer for obtain fire NOC as mentioned at Sr. No. 06 (a), (b) and (c) (i) to (xi) in appendix – VII.
- (4) The fee prescribed for renewal of fire NOC to the premises/building used for any one or more of the purposes which constitute fire risk as per Sections 13 of the Act and Rule 24 of this rule shall be Rs. 2500/- per annum as mentioned (d) in appendix – VII.

Declaration of VDA under the Minimum Wages Act, 1948.

In addition to the Basic Pay fixed by the Administration of Daman & Diu in respect of all the scheduled employments under the Minimum Wages Act, 1948 vide notification No. LE/LI/DMN/MWA-3(ii)/2015-16/81 dated 29/05/2015, the daily rate of Variable Dearness Allowance (VDA) payable on the cost of living index number is increased at the rate of ₹ 9.50/- with effect from 01.04.2016.

Sr. No.	Scheduled employments	Daily rate of VDA
1	Every employment in the schedule to the minimum Wages Act, 1948. (Part I & Part II)	9.70/-

Thus the minimum rates of wages payable in respect of all the employments in the schedule to the Minimum Wages Act, 1948 in the Union Territory of Daman and Diu is as under :

Minimum rates of wages payable per day

Category	Basic	VDA	Total
Skilled	284.00	9.70	293.70
Semi-Skilled	276.00	9.70	285.70
Un-Skilled	268.00	9.70	277.70

Note : For monthly wages, multiply with 26 days.
