ORDER

Whereas, The S.S.C/H.S.C Examination, 2017 are scheduled to be held in Diu from 15-03-2017 to 30-03-2017 between 10:00 to 2:00 P.M. and 2-30 P.M. to 6-00 PM. as per the Examination Time-Table declared by the Gujarat Secondary & Higher Secondary Education Board, Gandhinagar (Gujarat).

And Whereas, the following school have been declared as the Centre of Examination :-

- (i) Government Higher Secondary School, Near Fort, Diu
- (ii) Govt. High School (Girls), Main Bazar, Diu
- (iii) Govt. Higher Secondary School (Girls), Near Panjarapore, Ghoghla and
- (iv) Govt. Higher Secondary School, Near Tad-Check Post, Bucharwada

And Whereas, there is likelihood of number of people gathering around these Examination Centres and there is a possibility of disturbance of peace and public tranquility which may hamper the smooth conduct of the examination.

And Whereas; I am satisfied that there are sufficient grounds for proceeding under section 144 of the Code of Criminal Procedure, 1973 and that circumstances do not admit of serving Notices individually.

Now, Therefore; in exercise of the powers conferred to me under Section 144 of the Code of Criminal Procedure, 1973 (No. 2 of 1974), **I, P. S. JANI**, District Magistrate, Diu do hereby prohibit :-

- (1) Gathering of Public in general/individual for carrying out any illegal activity in and around the area of 100 meters of the Centres specified for the **S.S.C. & H.S.C. Examination.**
- (2) Carrying of Licensed/unlicensed arms and ammunitions or sharp weapons of offenses, sticks or lathi, Swords, daggers, cudgels, spears bludgeons, knives or any kind of other articles which is capable of being used for causing physical injury in Public place or otherwise during the period of **S.S.C. & H.S.C. Examination.**
- (3) Use of loudspeakers or static loudspeakers or sound producing instruments within a radius of 200 meters of the Centres specified for the **S.S.C. & H.S.C. Examination.**

And further direct that restrictions herein above, shall not apply to :-

- i) The Officers/Officials on duties in their respective officers situated within the premises of the Administration concerned with the maintenance of Law & Order in Diu District.
- ii) The Police Officers/Police personnel employed/deployed on their respective duties around the areas of the centres specified for **S.S.C. & H.S.C. Examination.**
- iii) The Government Servants of the Administration on duties in their respective officers situated within the premises.
- iv) Any other person duly authorized in writing by the District Magistrate for the particular purpose or meeting of any perils.
- v) The Tourist coming from the other states.

This order shall remain in force from 15/03/2017 to 30/03/2017 **09:30 A.M. to 06:00 P.M. daily.**

A W A R D

[1] This is the reference made vide letter No. LE/LI.DMN/FACT-4(7)/2011/196 made by the Deputy Secretary (Labour & Emp.), Daman under Sub Section 1 of Section 10 of the Industrial Disputes Act in respect of an Industrial dispute between M/s Sipra Remedies Pvt. Ltd. and its workman Shri Himmat Singh in respect of matter (1) Wages including the period and mode of payment provided in first schedule of Industrial Disputes Act.

[2] The second party filed the statement of claim at Exhibit-19. The respondent proceeded Exparte.

[3] Ld. Advocate Shri P. S. Modasia for Second Party.

[4] After evidence of Second party and as per Judgment and order following is the award.

A W A R D

- (i) The claim of second party / Himmat Singh is allowed.
- (ii) The first party / company is Sipra Remedies Pvt. Ltd. is directed to pay amount of Rs. 71,965/- rupees Seventy One Thousand Nine Hundred Sixty five Only) to the second party / claimant with interest at the rate of 8% per annum for the date of reference i.e. 27/06/2011.
- (iii) Award be drawn up accordingly.
- (iv) Copy of this award be sent to the concern for publication in the Official Gazette.
