NOTIFICATION

Whereas, the last General Election to the Diu Municipal Council was held on 17th June, 2012 and the duration of five years of the said Council from the date appointed for its first meeting is due to expire shortly.

And, whereas, Rule 22 of the Daman and Diu Municipalities (Elections) Rules, 1995 provides, inter alia, that "a general election shall be held for the purpose of constituting a new council on the expiration of its duration".

And, whereas, the Election Commission referred to in Section 5 of the Daman & Diu Municipalities (Amendment) Regulation, 1994 has recommended that the Administrator of the Union Territory of Daman & Diu may, by a notification to be published in the Official Gazette on 07th June, 2017, call upon all the wards of the Diu Municipal Council to elect members for the purpose of constituting a new Council on 1st July, 2017, if required.

Now, therefore, in pursuance of Rules 23 of Daman & Diu Municipalities (Elections), Rules, 1995, I, Praful Patel, Administrator, Daman & Diu, hereby call upon all the wards of the Diu Municipal Council to elect members in accordance with the provisions of the Daman & Diu Municipalities (Amendment) Regulation, 1994 and of the rules and orders made thereunder.
