NOTIFICATION

The Administrator of the Union Territory of Daman & Diu is pleased to notify the following airports under the Regional Connectivity Scheme of the Governemnt of India:

- A Diu Airport.
- B Daman Airport.

Also, as per Para 4.2.2 of the MoU signed with the Ministry of Civil Aviation, Government of India and Airports Authority of India, the following concessions shall be extended by the Unin Territory Administration of Daman & Diu:

- a) UT Administration shall charge VAT @ 0% on ATF at RCS Airports for RCS flights from other airports located within the state for a period of 10 years;
- b) UT Administration shall provide minimum land, if required, free of cost and free from all encumbrances for development and expansion of RCS Airports after due consideration based on extant policy of the UT on case to case basis. UT Administration shall also provide multi-modal hinterland connectivity (road, rail, metro, waterways, etc.) as required;
- c) UT Administration shall provide security and fire services free of cost at RCS Airports;
- d) UT Administration shall provide, or cause to be provided, electricity, water and other utility series at substantially concessional rates at RCS Airports; and
- e) UT Administration shall provide 10% share of VGF as determined pursuant to this Scheme. The UT Administration shall need to reimburse its VGF share within 3 months of being asked by the Central Government.
