**Declaration of VDA under the Minimum Wages Act, 1948.**

In addition to the Basic Pay fixed by the Administration of Daman & Diu in respect of all the scheduled employments under the Minimum Wages Act, 1948 vide notification No. LE/LI/DMN/MWA-3(II)/2015-16/81 dated 29/05/2015, the daily rate of Variable Dearness Allowance (VDA) payable on the cost of living index number is increased at the rate of ₹ 1.00/- with effect from 01.10.2016.

<b>Sr. No.</b>	<b>Scheduled employments</b>	<b>Daily rate of VDA</b>
1	Every employment in the schedule to the Minimum Wages Act, 1948. (Part I & Part II)	10.70/-

Thus the minimum rates of wages payable in respect of all the employments in the schedule to the Minimum Wages Act, 1948 in the Union Territory of Daman and Diu is as under :

**Minimum rates of wages payable per day**

<b>Category</b>	<b>Basic</b>	<b>VDA</b>	<b>Total</b>
Skilled	284.00	10.70	294.70
Semi Skilled	276.00	10.70	286.70
Un-Skilled	268.00	10.70	278.70

Note : For monthly wages, multiply with 26 days.
