1	Swachchh Angan Yojana	<p><b>Eligibility :-</b></p> <ol style="list-style-type: none"><li>1) Residents of Daman &amp; Diu who do not have a sanitary laterine in the house.</li><li>2) Annual Family income is less then Rs. 1,00,000/-</li></ol> <p><b>Design and Construction :-</b> Every laterine constructed under this scheme would essentially have septic tank and with a provision for a flush tank.</p> <p><b>Cost :-</b> Estimated Cost of Rs. 15,000/- (Rupees Fifteen Thousand Only)</p> <p><b>Pattern of Assistance :-</b> (i) This scheme will be funded by the Government of India under Swachchh Bharat Mission (Urban &amp; Rural) and supplemented by U.T. of Daman &amp; Diu under respective budget Head related to Sanitation and Cleanness of District Panchayat/Urban Local Bodies/ Gram Panchayat &amp; BDO (ii) This scheme will be implemented by the District Panchayat, Daman/Diu and the Municipal Council, Daman/Diu (iii) The eligible beneficiaries will avail the benefit of the scheme free of Cost.</p>
