NOW THEREFORE, in exercise of the powers conferred by Section 3 of the Goa, Daman and Diu Ancient Monuments and Archaeological Sites and Remains Act, 1978, the Administrator of Daman and Diu is hereby give the notice with an intention to declare and include Naida Caves, situated at Diu to be the ancient monument;

Objections, if any, to the declaration of the Naida Caves to be an ancient monuments may be made to the Collector, Diu within a period of two months from the date of issue of this notification, by any person interested in the said monument which will be taken into consideration by the Union Territory Administration of Daman and Diu.
