Whereas, the Administrator, Union Territory of Daman & Diu satisfied that the Union Territory of Daman & Diu is infected by and threatened with an outbreak of Malaria and Dengue.

And Whereas, the Administrator, Union Territory of Daman & Diu is of the opinion that the ordinary provisions of law for the time being in force in district of Daman & Diu are insufficient to prevent the outbreak and spread of the said diseases.

Now, therefore, in exercise of the powers conferred under Section 47, Section 75 and Section 96 of The Goa, Daman & Diu Public Health Act 1985, clause (b) of sub section (1) of Section 6 of the Regulation ibid of 1962 and clause (b) of sub section (1) of Section 7 of the Regulation of 1963 and Clarification by The Ministry of Home Affairs, New Delhi vide letter No. U-11026/1/93-UTS dated 9/2/1996 read with Article 239 of the Constitution of India and in the view of the D.O. letter No. 14-4/2016-17/NVBDCP/MTD/Malaria Elimination/ Pt. File, dated 07/06/2016, from Dr. A.C. Dhariwal, Director-NVBDCP, Directorate General of Health Services, Ministry of Health & Family Welfare, New Delhi and all the powers enabling him in this behalf, the Administrator, UT of Daman & Diu, is pleased to make the following regulations namely :-

**1. Short title and Commencement :-**

- (1) These regulations may be called "the Daman & Diu Prevention and Control of Malaria, Dengue and other Vector Borne Disease Regulation, 2016".
- (2) They shall come into force from the date of publication in the Official Gazette of Daman & Diu Gazette.

**2. Definitions :-** In these regulations unless the context otherwise requires :-

- (a) **"Infected Area"** means any place or area, which is notified by the District Magistrate, Daman/Diu under these regulations to be infected with Malaria, Dengue and other Vector Borne disease.
- (b) **"Controlling Officer"** means any officer appointed under these regulations, by the Administrator, Union Territory of Daman & Diu.
- (c) **"Threatened Area"** means any place or area, which is notified by the District Magistrate, Daman & Diu under regulation 3, to be threatened with infection of Malaria, Dengue and other vector borne diseases.

**3. Notification of place or area as Infected or threatened :-**

The District Magistrate, Daman / Diu, may by notification in the official gazette to declare :-

- (a) Any place or area in the district to be an infected area, and
- (b) Any place or area contiguous to any infected area in which, in his opinion, there is danger of outbreak of Malaria, Dengue and other vector borne disease.

**4. Appointment of Malaria, Dengue and other Vector Borne Disease Controlling Officer :-**

The District Magistrate, Daman/Diu, may subject to the general or special order of the Administrator, Union Territory of Daman & Diu appoint an Officer to be the Malaria, Dengue and other Vector Borne Diseases Controlling Officer for any infected or threatened area to carry out all of the measures prescribed under the regulations.

**5. Publication of list of infected city, town and villages and intimation of outbreak of Malaria, Dengue and other vector borne diseases :-**

When the District Magistrate, Daman/Diu, under the regulation 3 has declared any place or area to be an infected area, he shall cause the details of such place/area to be published in the official gazette. He shall further specify therein the information regarding Malaria and Dengue Controlling Officer as also the Passive surveillance centers established and other surveillance staff, for the treatment of Malaria Epidemiological and Entomological investigation for Malaria and Dengue and other Vector Borne Disease.

**6. Notification of persons suffering from Malaria, Dengue and Other Vector Borne Disease :-**

When Malaria, Dengue and other Vector Borne Disease breakout at any place, the District Magistrate, Daman/Diu shall cause the names and addresses of persons suffering from Malaria, Dengue and other Vector Borne Disease to be notified to the Dy. Director NVBDCP, Daman/DPO NVBDCP Diu.

**7. Powers of Malaria, Dengue and other Vector Borne Disease Controlling Officer :-**

In the city, town or village which is not a cantonment and which is situated in any infected area or a threatened area, the Malaria, Dengue and other Vector Borne Disease Controlling officers may,

- (a) require every owner or occupier of a building, Every Pathological Lab and every Medical practitioner to report every case of Malaria, Dengue and other Vector Borne Disease which may come to the notice of such owner, occupier or practitioner, to the Officer in charge of the nearest passive surveillance center like PHC, CHC and DH of Daman & Diu which are established surveillance center under the National Vector Borne Disease Control Programme.
- (b) Carry out or cause to be carried out intensive spraying operations in the building in which a case of Malaria and suspected case of Dengue occurred and in the surrounding buildings situated within a radius of 150 meters through any subordinate office of the National Vector Borne Disease Control Programme viz. CHC, PHC and sub Center.
- (c) Give preventive insecticidal indoor spraying in any type of premises including animal dwelling, shops or any other type of roofed structure in hamlets villages, labourer colonies, slums and low lying areas etc.
- (d) Carry on mass blood survey and mass drug treatment to the inhabitants temporary labourer and casual visitors in the affected area, as the situation may demand.
- (e) Give such directions to the contractor, employers or employing labourer at the sites of projects like Irrigation roads buildings etc. with a view to prevent and control of the outbreak of Malaria, Dengue and other Vector Borne Disease at such sites.

**8. (1) No person shall :-**

- (a) Keep or maintain any collection of standing or flowing water in which mosquitoes breed or are like to breed or
- (b) Cause permit or suffer any water within such area to form a collection in which mosquitoes breed or are likely to breed, unless such Collection has been effectively protected to prevent such breeding.
- (c) Occupy a new building (private, government or semi-government) unless an occupation certificate is obtained from the Controlling Officer, regarding the requirements of anti mosquito system in these premises.

(2) The natural presence of mosquito larvae, pupae in any standing or flowing water shall be evidence that mosquitoes are breeding in such water in premises, institutions, offices or dwelling units.

**9.** (1) The Inspecting Officer may from first time by notice in writing require the owner or the occupier of any place, containing any collection of water in which mosquitoes breed or are likely to breed, within such time as may be specified in notice, not being less than 24 hours, to take such measures with respect to the same or to treat the same by physical, chemical, biological and other methods, or as the Inspecting Officer may consider suitable in the circumstances for the prevention and control of Malaria, Dengue and Vector Borne Disease.

(2) If the person on whom a notice is served under sub regulation :

Fails or refuses to take measures or adopt the method of treatment, specified in such notice within the time mentioned therein, the Inspecting officer may himself take such measures or adopt the method of such treatment and recover the cost along with service charges for doing so, from the owner or occupier of the property, as the case may be.

**10.** Where, with the object of preventing breeding of mosquitoes in any land or building, the owner or the occupier at his instance has constituted any works in such land or building the owner or the occupier for the time being of such land or building shall prevent its being used in any manner which cause or is likely to cause the deterioration of such works, or which impairs or is likely to impair their efficiency.

**11.** (1) No person shall, without the consent of the Inspecting Officer interfere with injure, destroy or render useless, any work executed or any material of thing placed in, under or upon any land or building by or under the orders of the Inspecting Officer, with the object of preventing the breeding of mosquitoes therein.

(2) If any person contravenes the provisions of sub regulations (1) the Inspecting Officer may re-execute the work or replace the materials or things, as the case may be and the cost along with service charges for doing so shall be recovered from such person.

**12.** The owner or the occupier of any house, building or shed or land shall not therein keep any bottle, vessel, can, auto-tyre or any other container broken or unbroken in such a manner that it is likely to, collect and retain water which may breed mosquitoes.

**13.** All burrow pits required to be dug in the course of construction and repair of roads, railways, telecommunication, embankments etc shall be so filled so as to ensure that the water does not remain stagnate therein where possible and practicable, the burrow pits shall be left clean, free from dead men and sharp edge and extra expenditure not exceeding one percent of the cost of the earth work in any project maybe incurred to achieve this. The bed level of burrow pits shall be so graded and profile that water will drain off by drainage channels connecting one pit with the other till the nearest natural drainage nullah is met with. No person shall, create any isolated burrow pits, which is likely to cause accumulation of water, which may breed mosquitoes.

**14.** In case of any dispute or difference of opinion in the execution of any anti mosquito scheme or in its operation or any work under these provisions in which the jurisdiction of the Government of India, or Government of any other State is involved, the matter shall be referred to the Government of India for final decision in the matter.

**15.** For the purposes of enforcing the provisions of these regulations, the Inspecting Officer or any of his subordinates not below the rank of Health or Sanitary Inspector or Malaria Inspector or Surveillance Inspector, Multi-Purpose Workers and Insect Collectors, may at all reasonable times after giving such notice in writing as may appear to him reasonable, enter and inspect any land or building within his jurisdiction and the occupier or the owner as the case may be of such land or building shall give all facilities necessary for such entry and inspection, and supply all such information as may be required by him for the purpose aforesaid.

**16. Obstruction to performance of duty prohibited :-** Every person shall duly comply with an order or requisition issued under these regulations and no person shall obstruct the performance of any of the duties imposed upon anyone by these regulations.

**17. Constitution of Mobile Court :-** In case of epidemic or situation leading to epidemic of Malaria, Dengue and other vector borne disease, the Administrator Union Territory of Daman & Diu may authorize the Malaria, Dengue and other vector borne disease Controlling Officer for constituting a Mobile Court for certain period so as to impose fine or penalty to the owners, occupiers of premises creating conditions conducive for transmission and spread of Malaria, Dengue and Vector Borne Disease inside the houses/offices, markets, shopping complex, institutions or any other place located within the jurisdiction of UT of Daman & Diu.

**18. Involvement of Private Practitioner, clinicians and Nursing Homes :-**

(1) All the private practitioner, clinicians/doctors in charge of nursing homes, medical institutions, clinical laboratories etc. within the jurisdiction of Union Territory of Daman & Diu shall furnish information pertaining to blood slide collection and positive cases, information regarding the suspected/confirmed cases of Dengue to the Malaria/Dengue/other Vector Borne Disease Controlling Officer Dy. Director NVBDCP, Daman/DPO NVBDCP Diu.

Doctor, In charge of the aforesaid clinics, nursing homes, medical institutions, clinical laboratories etc shall send examined blood slide as and when required by the Malaria, Dengue, other Vector Borne Disease Controlling Officer for the purpose of cross checking.

**19. Screening of migrant labourers at the construction sites and factories :-**

Contractors or employers of any construction site and factories (Government or private agency) shall be responsible for getting all the migrant labourers or employees screened for Malaria and Dengue at the nearest malaria clinics or through mobile squads, surveillance teams deployed under the National Vector Borne Disease Control Programme of the State/UT Government. No labourer or employees shall be engaged by the contractors or employer at the construction sites and factories unless he/she has been screened for Malaria and Dengue.

- 20. Penalty :-** Whosoever contravenes any of the provisions of these regulations, disobeys any order or requisition issued thereunder or obstructs any measures which are required to be taken by the Government for which the Malaria, Dengue and Other Vector Borne Disease controlling Officer has been required or empowered to take under these regulations shall be deemed to have committed an offence under Section 188 IPC, rendering himself liable to punishment provided therein with a fine of Rs. 500/- (Rupees five hundred only) for each offence.

AND WHEREAS, the copies of the said Gazette were made available to the public on the 30<sup>th</sup> June, 2017.

AND WHEREAS, No objections and suggestions received on the said draft rules have been considered by the Daman & Diu Administration.

NOW, THEREFORE, in exercise of the powers conferred by Section 211 of Motor Vehicles Act, 1988 (Central Act 59 of 1988) and as amended by Act No. 54 of 1994, the Administrator of Daman & Diu is pleased to amend the Daman & Diu Motor Vehicles Rules, 1989 as follows :

1. Short title and commencement :
  - (1) These Rules may be called the Daman & Diu Motor Vehicles (Amendment) Rules, 2017.
  - (2) They shall come into force at once.
2. Amendment of Rule 315 :- In Daman & Diu Motor Vehicles Rules, 1989, Rule 315 shall be substituted as below :-
  - 315 (1) The fee for allotment of a registration number at the choice of the applicant is specified in the schedule – I to III appended herewith.
  - (2) The owned of vehicle desiring to obtain a number of his choice under this rule should apply in SEALED Envelop with "RESERVED NUMBER – LMV/TWO WHEELER/TRANSPORT VEHICHEL" written over it with name and phone number and the envelop should contain the request for allotment of Reserved number on a Choice Number Application (CNA) Form along with a copy of Form – 21 (Sale Certificate) and payment of prescribed fee for the reserved Number to the Registering Authority.

- (3) All the reserved number shall be allotted only in the first working day of each month. If the applicant or his authorized representative remains absent during the allocation, the fee paid will be forfeited without any intimation, if there are two or more applicants for the same number.
- (4) Whenever more than one person applies for the same Registration Number; the number shall be allotted by way of Auction. The number shall be allotted to the highest bidder in such case.
- (5) The department will auction all the reserved number till the facility of auction through online or VAHAN is available.
- (6) The Registration Number for vehicles belonging to the Government or Semi-Government or Government Undertaking will be allocated irrespective of class or series that is Two Wheeler/Light Motor Vehicle/Transport Vehicles from the open series. The Registering Authority will exercise the authority to allot these numbers.
- (7) The unreserved numbers in the series are exhausted thereafter only remaining un-allotted reserved number will be allotted in the routine manner.
- (8) The registration number under these rules shall be allotted only from the prevailing series in the jurisdiction of the concerned Registering Authority, subject to the availability. No request for allotment of registration number from a series not yet opened shall be entertained.
- (9) There will be one series for allotment of registration number for LMV and Transport Vehicle. The registration number from 1 to 9000 and 9999 will be for LMV and numbers from 9001 to 9998 will be for Transport vehicle.

There will be separate series for the registration of Two Wheelers, which will start from registration number 1 to 9999.
- (10) The new Series will be opened automatically but only after exhausting the number in the current series.
- (11) Henceforth, the new series will be opened only after exhausting series up to AJ as per above.
- (12) Registration Numbers so allotted under these rules will be non-transferrable.
- (13) The fee paid for the purpose will be non-refundable for allotment without auction and for allotment by way of auction; the fee will be refunded to the applicants who are not able to get the number.
- (14) The decision of the Registering Authority as regards issue of Choice Registration Numbers and auction shall be final.
- (15) These Rules shall supersede all the earlier orders or instructions issued in this behalf. It is also further clarified that no circular or administrative order shall have precedence under the provisions of these Rules i.e. Daman & Diu Motor Vehicle (First Amendment) Rules, 2017.
