## ORDER

Read :- Notification No. SFD/3/22/MFRA/2015-16/10 dated 10-12-2015

In order to conserve fish and regulate the fishing on a scientific basis, (i) specified area up to 9 km from the shore is reserved for non-mechanized fishing vessels only. Fishing shall be prohibited by mechanized vessels i.e. by means of Trawl net, Purse-seine net & Gill net etc., in that area.

- (ii) Further, catching of juveniles of fishes is also be prohibited.
- (iii) Further, no Trawl net/Purse-seine gear having less then 40 mm mesh size and gill net with 150 mm shall be operated by any mechanized fishing vessels.
- (iv) Further, fishing shall be banned for mechanized vessels i.e. by means of Purse-seine net from 1<sup>st</sup> March to 15<sup>th</sup> September, every year.
- (v) The **20 nos. of Purse Seine fishing License of Daman** shall be issued every year.
  - No renewal as such any license shall be done automatically.
  - Any person who has an existing license shall have to apply a fresh every year.
  - Every year the expression of interest to issue the purse seine fishing licenses in the month of June (during the ban period) will be called by the department.
  - Same will be finalized in the month of July, so that they can make their readiness.
  - If, the no. of applications will exceed, same will be finalized through lottery system along with the waiting list of 5 nos.
  - Department will verify the readiness in the month of August of the fishing boat with complete documents including list of Khalasi/crew, NOC of Port Department etc.
  - After verification fix nos. of licenses will be issued to the boat owners up to the 10<sup>th</sup> of September to do the purse seine fishing only for the one season w.e.f. 16<sup>th</sup> September to February every year.
  - In case the selected boat owner dose not have readiness or required documents or dose not turn up for issuances of license, then the remaining licenses will be open for the waiting list applicats on first come first serve basis.
  - Licence shall not be transferable.
  - Every fishing boat have to be fitted with VTS and provide the quantity and type of fish catch and location details of every fishing trips to the department.

**PREAMBLE :**

UT's economy has reached a critical size which is a strong platform to launch itself on an accelerated and high growth trajectory. The UT of Daman & Diu and Dadra & Nagar Haveli have always been in the fore front of economic growth in the country. UT's Industrial Policy 2015 emphasizes on infrastructure development. UT's competitive economic advantage clearly depends on strong, articulated vision for industrial and infrastructure development. The UT's has decided to focus more on comprehensive infrastructure facilities to the project proponents across the UT's; the Industrial Policy seeks to create adequate provisions which aim to upgrade and improve the status of infrastructure in the UT's.

In recent year, these UT's Administration has taken up many initiatives for creation of new infrastructure and up-gradation of infrastructure in industrial areas and estates, facelift of existing infrastructure, leveraging from critical infrastructure scheme. It is recommended to extend support to maintain competitiveness of enterprises by modifying schemes in operation. In continuation of the same, it has been decided to introduce a scheme for improvement of infrastructure in OIDC/Non-OIDC Estates/Private Estates/Industrial Areas. To enable the industrial clusters to address their comprehensive infrastructural needs and initiate steps for fulfilling their needs by utilizing these schemes and to ensure commitment and complete involvement of the benefiting units. It is necessary to expect financial involvement of the units collectively with a contribution in the project cost. Further UT Administration decided to modify the existing scheme and to make them globally competitive.

**RESOLUTION :**

In view of the strategy under New Industrial Policy, the UT Administration of Daman & Diu is pleased to introduce a "**Scheme for Assistance for Industrial Infrastructure**" which will come into force from the date of **Notification in Official Gazette** and will remain in operation for a period of five years.

**DEFINITIONS :**

**1.1 Industrial Area/Infrastructure**

- (a) Industrial area means a contiguous parcel of piece of land converted for Non Agricultural Industrial Purpose or having valid permission to use land as Industrial purpose or having notified by the competent authority.

- (b) The NA Conversion permission shall be accorded by from Competent Authority of UT Administration for Industrial Area.
- (c) The NA permission shall have validity for Industrial Area on the day of submission of Claim for assistance by eligible Institution/Agency.
- (d) The Industrial area land should have valid layout plan permission from the Competent Authority i.e. Planning Authority as per UT's DCR.
- (e) The minimum area of land for the scheme shall be 25000 sq. mtr. for new products.

### 1.2 Eligible Agency

- (a) **Institution :-** Eligible institution means any Industries Association, Chamber of Commerce and Industries, Federation of Industries or SPV of Industries (which are registered under Societies Act, Trust Act or the Companies Act) or any Large project/Group of industries are eligible.
- (b) **Government Department :-** Any Government Department, Govt. Agency or Authority, State and Central Govt. PSUs, Boards, Corporations, Municipal Corporations/Councils will be treated as eligible Institution those having experienced and executed such project since inception of the Department.
- (c) **A Developer/Contractor:-** A Developer/Contractor registered with the UT Administration having work experience of at least 5 years for development of Industrial Estates area not less than 10 hectares any where in India.

### 1.3 Eligible Activities

- (i) Common Infrastructure facilities as may be required in an industrial estate (both O IDC and Non-O IDC Industrial Estates), Industry clusters or industrial area and/or linked infrastructure/last mile connectivity for industrial estate/cluster/area, such as :
  - a) Approach road from industrial estate/area to Highways/MDR
  - b) Up gradation of existing roads/widening of roads
  - c) Water/Gas/electricity/energy distribution networks
  - d) Transport Nagar/Transport facilities, Water Augmentation Facility
  - e) Any other infrastructure facilities as approved by Implementation Committee.
  - f) Any other infrastructure as defined in DCR of Planning & Zoning regulation of UT's.
- (ii) Up-gradation of infrastructure facilities in the estate which has been established.
- (iii) Link infrastructure facilities and last mile connectivity to large project, Central and State Industrial PSUs.
- (iv) Setting up of Convention Centre, Exhibition Centre, and Infrastructure Development of SIRs, clusters/Large Industrial Estates/Upcoming Industrial estates-areas etc. as approved by implementation committee.



#### 1.4 Eligible Investment.

- (i) Fixed capital investment in the components of project of critical infrastructure (excluding land cost) as approved by the Empowered Committee will be eligible.
- (ii) Cost of preparation of work estimates, cost of technical approvals and cost of third party Inspection for Quality assurance expenses maximum @ 3% of the project cost will be eligible.

1.5 In case of any dispute or discrepancy as regard to the definition, the decision of Committee shall be final & binding to all concerned.

#### 2.0 QUANTUM OF ASSISTANCE

1. Under the scheme, assistance will be considered up-to **50% of project cost or Rs. 20 Crore per project whichever is less.**
2. Committee may sanction upto 100% assistance to the projects of Govt. Departments Govt. Agency or Authority, State and Central Govt. PSUs, Board.
3. The Committee may consider undertaking specific studies for specific industries/ industrial area/industrial development activities through professional institutions/ reputed consultancy firms under the scheme and expenditure for such study will be incurred under this scheme.
4. In case there is no stakeholder for the development of the infrastructure of the industrial area/estate, Industries Secretary may appoint agency to undertake study on requirement of critical infrastructure and put up to empowered committee for sanction of project and to appoint agency to execute the work.

#### 3.0 PROCEDURE:-

- (i) The Eligible Institution will apply with project report to Department of Industries, Daman & Diu.
- (ii) The Department of Industries will scrutinize the proposal with the consultation of Chief Engineer, PWD/OIDC and Finance Department on Technical & Financial aspects of the project and then place before the empowered Committee for decision.
- (iii) Assistance will be released at following stages :
  - 25% after completion of 25% work progress.
  - 25% after completion of 50% work progress.
  - 50% after completion of project.
- (iv) Final payment will be made on completion of Project & Physical verification of Engineer of UT's Administration and production of Completion certificate issued by authorized Third Party Agency.
- (v) UT Administration has to right to change, withdraw or modify the scheme fully or partially at any stage.

#### 4.0 OTHER CONDITIONS:-

- a) The component of the Project will not be eligible for assistance under this Scheme, if the said component has already been sanctioned under any other scheme of the UT Administration, unless specified otherwise. However, if assistance is availed under Central Govt. Scheme, the assistance together of UT Administration and central government scheme should not exceed the project cost.
- b) The disbursement of the assistance sanctioned will be in proportionate to the expenditure incurred in case of non-Government project.
- c) The applicant shall have to prepare a detailed project report, clearly highlighting the overall infrastructural needed for the estate and industrial area and its impact on industrial and social sector. The project cost should also indicate the means of finance in terms of contribution of applicant.
- d) The Project Cost or Estimate prepared shall be based on rates of the Schedule Rate (SOR) of UT or SOR adopted by UT prevailing at that time.
- e) If the cost of the items which are not in SOR of UT or SOR adopted by UT then the rates shall be worked out by Rate Analysis by taking basic rates of materials & Labour prevailing in UT.
- f) If the rates are not available even after following above, then the decision of the Committee shall be final & binding to all concerned.
- g) The Procedure/Instructions laid down C.P.W.D. Work Manual, Directives from GOI, Standing Orders of Administration, Procedure laid to follow as sound Engineering Practice of IS Code/Manual of Engineering shall have to be followed by the agency while executing the work.
- h) The agency shall have not claim any legal rights of ownership of Infrastructure since its commencement of development.
- i) The UT level Committee has all right reserved in case of any dispute with the agency and its decision with appropriate carom shall be binding to all concerned.

#### 5.0 UT LEVEL EMPOWERED COMMITTEE

A UT Level Empowered Committee consisting of following members is constituted for approval of project and rate of assistance under the scheme.

- i. The Committee will review the progress of the sanctioned project
- ii. The Committee will stipulate other conditions for the implementation of the project, if required which shall be binding to the applicant.
- iii. In case of any issue regarding interpretation of the scheme, the UT Level Committee will be the authority to give clarification/decision, keeping in view the objective of the scheme, which will be final & binding to all the concerned.
