NOTIFICATION

In exercise of the powers conferred by the provision to Article 309 of the Constitution, read with the Department of Personnel and Training O.M. No. A-12022/03/2016-Ad.II dated 11th November 2016, and O.M. No. A-AB.14017/13/2016-Estt.(RR) dated 9th August 2016, the Administrator of Daman & Diu is pleased to make the following rules relating to recruitment to the General Central Service Group "C" & "Multitasking Staff" (Non-Gazetted, Non Ministerial) posts in the office of the Controller of Weights & Measures, under the Administration of Daman and Diu namely :

(1) **Short title application and commencement :**

- (i) These rules may be called the Administration of Daman and Diu Group "C" & "Multitasking Staff" (Non-Gazetted, Non Ministerial) Post Recruitment Rules, 2016.
- (ii) These rules shall apply to the post specified in column of the Schedule to these Rules and shall come into force from the date of publication in the Official Gazette.

(2) **Number, classification and scale of Pay :**

The number of posts, classification of the said posts and the scale of pay attached thereto shall be as specified in column 2 to 4 of the schedule to these rules. Provided that, the Administrator of Daman & Diu may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

(3) **Method of Recruitment, Age limit and other qualifications :**

The Method of Recruitment to the said posts; age limit, and other matters connected therewith shall be as specified in columns 5 to 13 of the said schedule.

(4) **Disqualification :**

No person (a) who has entered into or contracted a marriage with a person having a spouse living or (b) who, having a spouse living has entered into or contract a marriage with any person, shall be eligible for appointment to the service provided that the Administrator of Daman & Diu may, if satisfied that such a marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

(5) **Power to relax :**

Where the Administrator of Daman and Diu is of the opinion that it is necessary to expedient so to do, it may by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

(6) **Saving :**

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Caste and Scheduled Tribes and other special categories of persons in accordance with the order issued by the Central Government from time to time in this regard.
