**THE SCHEDULED CASTES AND THE SCHEDULED TRIBES  
(PREVENTION OF ATROCITIES) AMENDMENT ACT, 2018**

No. 27 OF 2018

[17<sup>th</sup> August, 2018.]

An Act further to amend the Scheduled Castes and the Scheduled Tribes  
(Prevention of Atrocities) Act, 1989.

BE it enacted by Parliament in the Sixty-ninth Year of the  
Republic of India as follows:-

1. (1) This Act may be called the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2018. Short title and commencement
2. It shall come into force on such date as the Central Government may, by notification in the Official Gazette, appoint.
