NOTIFICATION

In exercise of the powers conferred by the proviso to the article 309 of constitution of India read with Government of India, Ministry of Personnel, Public Grievances and Pensions, New Delhi's Office memorandum No. AB.14017/13/2016-Estt.(RR) dated 09.08.2016, the Administrator, Daman, Diu and Dadra & Nagar Haveli is pleased to make the following rules regulating the method of recruitment to the post(s) of **Forest Guard/Forest Sepoy, Group 'C' (Non-Gazetted, Non-Ministerial)** in the Department of Environment & Forests in the Union Territory of Daman and Diu Administration namely :-

1. Short Title and commencement :-

- (i) These rules may be called, the Administration of Daman and Diu, **Forest Guard/Forest Sepoy, Group 'C' (Non-Gazetted, Non-Ministerial)** Post(s) Recruitment Rules, 2017.
- (ii) These shall apply to the post(s) specified in column-1 of the Schedule to these rules.
- (iii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the post(s) of Forest Guard/Forest Sepoy made on or after this date.

2. Number of Posts, Classification and Scale of Pay:-

The number of the post, classification of the said post and the scales of pay attached thereto shall be as specified in Column 2 to 4 of the Schedule to these rules.

Provided that, the Administrator of Daman, Diu and Dadra & Nagar Haveli may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

3. Method of recruitment, age limit, qualifications etc:-

The method of recruitment to the said post, age limit, qualifications and other matters relating therewith shall be as specified in column 5 to 13 of the aforesaid Schedule.

4. Disqualification:-

No person, (a) who has entered into or contracted a marriage with a person having a spouse living or; (b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the service.

Provided that the Administrator of Daman, Diu and Dadra & Nagar Haveli, may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax:-

Where the Administrator is of the opinion that it is necessary or expedient so to do, he may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving :-

Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes, and the other special categories or persons in accordance with the orders issued by the Central Government from time to time in this regard.

In exercise of the power conferred by the sub-section (1) of section 102 of the Daman & Diu Value Added Tax Regulation, 2005 (1 of 2005), the Government hereby amends the Rules 34 of the Value Added Tax Rules, 2005 (herein after referred to as the said Rules) in the following manner, namely-

(1) The provision to be added in Sub Rule (7) of Rule 34 as-

"Provided that the Commissioner may transfer the amount of refund to the bank account of the dealers by issuing a refund voucher in Form DVAT-22B or by National Electronic Fund Transfer (NEFT) or Real Time Gross Settlement (RTGS) or by Internet Banking and the Dealer shall provide to the Commissioner once, Bank Mandate form as prescribed under this proviso after receiving refund order in form DVAT-22".
