### ORDER

**Whereas**, the S.S.C./H.S.C. Examination, 2018 which is scheduled to be held in Diu from 12/03/2018 to 28/03/2018 between **10:00 a.m. to 2:00 p.m. and 2:30 p.m. to 6:30 p.m.**, as per the Examination Time-Table declared by the Gujarat Secondary & Higher Secondary Education Boards, Gandhinagar(Gujarat);

**And Whereas**, the following school have been declare as the Centre of Examination :-

1. Government Higher Secondary School Diu, Fort Road, Diu (S.S.C. & H.S.C.)
2. Government High School (Girls) Diu, Main Bazar, Diu
3. Government Higher Secondary School(Girls) Ghoghla, Near Panjarapore, Ghoghla
4. Government Higher Secondary School Bucharwada, Near Tad Check post, Bucharwada.

**And Whereas,** there is likelihood of a number of people gathering around these Examination Centres and there is a possibility of disturbance of peace and public tranquility which may hamper the smooth conduct of the examination.

**And whereas,** I am satisfied that there are sufficient grounds for proceeding under section 144 of the code of Criminal Procedure, 1973 and that circumstances do not admit of serving notices individually;

**Now, therefore;** in exercise of the powers conferred to me under Section 144 of the Code of Criminal Procedure, 1973 (No.2 of 1974), **I, HEMANT KUMAR,** District Magistrate, Diu do hereby prohibit :-

- (1) Gathering of Public in general/individual for carrying out any illegal activity in and around the area of 100 meters of the Centers specified for the S.S.C. & H.S.C. Examination.
- (2) Carrying of Licensed/unlicensed arms and ammunitions or sharp weapons of offenses, sticks or lathi, Swords, daggers, cudgels, spears bludgeons, knives or any kind of other articles which is capable of being used for causing physical injury in Public place or otherwise during the period of S.S.C. & H.S.C. Examination.
- (3) Use of loudspeakers or static loudspeakers or sound producing instruments within a radius of 200 meters of the Centers specified for the S.S.C. & H.S.C. Examination.

**And further** direct that the restrictions herein above, shall not apply to :-

- i) The Officers/Officials on duties in their respective offices situated within the premises of the Administration concerned with the maintenance of Law & Order in Diu District.
- ii) The Police Officers/Police personnel employed/deployed for duties in and around the areas of the Centers specified for S.S.C. & H.S.C. Examination.

- iii) The Government Servants of the Administration on duties in their respective offices situated within the premises.
- iv) Any other person duly authorized in writing by the District Magistrate for the particular purpose or meeting of any perils.
- v) The Tourists coming from the other states.

This order shall come into force from 12/03/2018 to 28/03/2018 between **09:30** A.M. to **06:30** P.M. as per the exam schedule till the entire period of examination is over.
