**REPORT OF REHABILITATION & RESETTLEMENT**

It was Notified by UT Administration of Daman & Diu by the Revenue Department vide Preliminary Notification No. 3/19/2017/LQN-Helipad/2017-18/2962 dated 23/03/2018 that the lands described in the schedule hereto (hereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose namely for the purpose of **construction of road for Helipad at Village Dunetha, Nani Daman.**

The report dated 03/07/2018 received from the Mamlatdar, Daman mentions that livelihood of land holders of the said area is not directly dependent on the land being acquired. At present they are not cultivating the lands which are under acquisition for construction of road for Helipad at Village Dunetha, Nani Daman.

This Summary of Rehabilitation & Resettlement is made under the provisions of Section 16(2) of the Right to Fair Compensation and transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) to whomsoever it may concern.
