Whereas directions were issued to the State Transport Authority, Daman & Diu vide Notification No. ADTr./DMN/343/2003-04/13 dated 23/07/2003 for fixing of fares chargeable for taxis and auto rickshaws in the Union Territory of Daman & Diu at the rates mentioned therein:

And Whereas a Committee was constituted under Clause (i) of Sub-Section (1) of Section 67 of the Motor Vehicles Act, 1988 for fixation of rates/fares for Auto Rickshaw and Taxi vide Order No. ADTr./DMN/343/2017-18/965648 dated 26/10/2018;

And whereas the Committee, after taking into consideration of the views of all stakeholders like Association of Auto Rickshaw & Taxi in a meeting held on 12/12/2017, have recommended for fixation of rates and fares of Auto Rickshaw and Taxi;

Now, therefore, in exercise of the power conferred by clause (i) of Sub-Section (1) of Section 67 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988) and all other powers enabling it in that behalf, the Administrator of Daman & Diu is hereby pleased to issue directions to the State Transport Authority, Daman & Diu and Regional Transport Authority, Diu that the fares chargeable for auto rickshaws and taxis in the Union Territory of Daman & Diu shall be as specified below:

(A) Auto Rickshaw :-

Fare	Rs. 19 for first fall of 2 Km. (upon downing the meter) and thereafter Rs. 6.50 per Kilometer for every additional Kilometer.			
Night Charges	Rs. 25% of the fare (11.00 PM to 5.00 AM;			
Waiting Charges	Rs. 30 per hour or part thereof (subject to a minimum of 15 minutes stay);			
Luggage Charges	Rs. 7.50 shall be charged as Extra Luggage charges whereas the driver/operator shall not charge any money for a shopping bag or a small attached/suitcase.			

(B) Taxis (CNG):-

Fare	Rs. 20 for first Km. (upon downing the meter) and thereafter Rs. 11.00 per Kilometer for Non ACT Taxis and Rs. 13.00 per Kilometer for AC Taxis for every additional Kilometer;
Night Charges	Rs. 25% of the fare (11.00 PM to 5.00 AM;
Waiting Charges	Rs. 30 per hour or part thereof (subject to a minimum of 15 minutes stay);
Luggage Charges	Rs. 10.00 shall be charged as Extra Luggage charges whereas the driver/operator shall not charge any money for a shopping bag or a small attached/suitcase.

This Notification shall come into force from the date of its publication in the Official Gazette.
