NOTIFICATION

The Administrator of Daman & Diu is pleased to provide Reservation for Economically Weaker Sections (EWSs) in Civil posts and services in the U.T. Administration of Daman & Diu in pursuance of the Constitution (One Hundred and Third Amendment) Act, 2019 and in

accordance with the provisions stated in the references quoted at the preamble from Sr. Nos. 2 to 4.

Whereas, in pursuance of insertion of clauses 15(6) and 16(6) in the Constitution wide the Constitution (One Hundred and Third Amendment) Act, 2019 and in order to enable the Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes, to receive the benefits of reservation on a preferential basis in civil posts and services in the Government of India and admission in Educational Institutions, it has been decided by the Administration of Daman & Diu to provide 10% reservation to EWSs in civil posts and services in Government of India and Admission in Educational Institutions.

The reservation for EWSs shall be governed by the O.M.s quoted in the preamble above.

The Deputy Director of Social Welfare, Daman & Diu, Daman is hereby designated as Liaison Officer for implementation of reservation for the Economically Weaker Sections (EWSs) and to certify the Reservation Roster as per the guidelines issued by concerned Ministry from time to time for ensuring proper compliance of instructions pertaining to reservation for Economically Weaker Sections (EWSs).

The Mamlatdar, Daman and Diu shall issue the Income & Assets Certificate for Economically Weaker Sections (EWSs) in Daman & Diu respectively in the prescribed format as per the guidelines issued by the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, O.M. F.No. 36039/1/2019-Estt.(Res) dated 19th January, 2019 & 31st January, 2019. The detailed standard operating procedure pertaining to issue of Income and Assets Certificate shall be issued separately by the Department of Revenue.

The Collector of the concerned District is declared as the Grievances Redressal Officer to redress the grievances of public for the Economically Weaker Sections (EWSs) as per the guidelines issued by the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, O. M. F. No. 36039/1/2019-Estt.(Res) dated 19th January, 2019 & 31st January, 2019.

The recruitment roster for the posts based on All India reservation shall be as per the Department of Personnel and Training, O. M. No. F. No. 36039/1/2019-Estt.(Res) dated 31st January, 2019.

The model recruitment roster for the posts based on local reservation duly vetted by Social Welfare department is annexed herewith. Post based reservation roster shall be prepared separately by every Government Establishment after due vetting by Social Welfare department.
