NOTIFICATION

Whereas, a proposal had been received from Chief Executive Officer, District Panchayat, Daman that the Dabhel Gram Panchayat has huge population of 57531 (as per 2011 census data) and number of voters (11401), which is on very higher side in comparison to other Gram Panchayats in Daman District. It has also been reported that various administrative difficulties are being faced in administering affairs of Dabhel Gram Panchayat, and it is also not possible to maintain the ratio envisaged under Section 12 of the Daman & Diu Panchayat Regulation 2012, between the population of territorial area of Gram Panchayat and number of seats in that Panchayat which should be same so far as predicable throughout the Union Territory. Further, it has also been reported that exclusion of some areas out of Dabhel Gram Panchayat and constitution of separate small Panchayat areas will lead to greater administrative efficiency, more effective supervision and implementation of welfare schemes/activities as well as effective monitoring of works and schemes for the benefit of citizens, timely delivery of public services, and maintenance of hygiene and proper cleaning of the Panchayat areas. Moreover, the Dabhel Gram Panchayat would be able to utilize available funds for welfare activities much better;

Whereas, the Administrator, UT of Daman & Diu, on due consideration of the above proposal and after making such inquiries as thought necessary, desired consultation with Gram Sabha Dabhel under Section 6 of the Daman & Diu Panchayat Regulation 2012, regarding exclusion of certain Panchayat areas from the territorial jurisdiction of Dabhel Gram Panchayat under clause (b) of sub-section (1) of section 6 of the said Regulation;

Whereas, in compliance of the above, it was conveyed vide letter No. BDO/DMN/GPSPL/2019/543 dated 18/07/2019, addressed to the Sarpanch of Dabhel Gram Panchayat requiring the Sarpanch to convene an extraordinary meeting of the Dabhel Gram Sabha under Rule 5 of the Daman & Diu Panchayat Administration Rules, 2015 within a week for consultation with the Gram Sabha Dabhel about the proposed exclusion of certain areas from Gram Panchayat Dabhel;

Whereas, the Sarpanch convened the extraordinary meeting of Gram Sabha Dabhel vide circular dated 18/07/2019, to be held on 25/07/2019 at 11:00 am to consider, inter-alia, the above proposal;

Whereas, the BDO vide his letter no. BDO/DMN/GS19/25JUL/2019-20/430 dated 26/07/2019 conveyed the Resolution passed by the Dabhel Gram Sabha in the meeting held on 25/07/2019, wherein the Gram Sabha Dabhel, after due deliberations and consideration of the proposal, passed the following unanimous resolution;

"Resolved that the Gram Sabha Dabhel unanimously endorses the proposal to exclude Ward Nos. 1, 2, 3, 4, 5, 7, 9, 10, 12, 13 & 14 or any other area as deemed appropriate, from the territorial jurisdiction of Dabhel Group Gram Panchayat which will be in public interest as after such exclusion, constitution of smaller Gram Panchayats will lead to greater administrative efficiency, more effective supervision and implementation of welfare schemes/activities as well as effective monitoring of works and schemes for the benefit of citizens, timely delivery of public services and maintenance of hygiene and proper cleaning of the Panchayat areas as well as better utilization of available funds for welfare activities in the Gram Panchayats. The Gram Sabha expresses its gratitude to the UT Administration for the initiative taken by the UT Administration for this proposal and the consultation sought from the Gram Sabha. The Gram Sabha further resolves that the UT Administration may be requested to consider the exclusion of the above stated wards or any other Panchayat area as deemed appropriate by the UT Administration from the Dabhel Gram Panchayat for constitution of separate smaller Gram Panchayats";

Now, therefore, after making such inquiries as deemed necessary and due consideration of the resolution passed by the Gram Sabha, in exercise of his powers under clause (b) of sub-section (1) of section 6 of the Daman & Diu Panchayat Regulation 2012, the Administrator of UT of Daman & Diu, is pleased to exclude the following Panchayat areas from the territorial jurisdiction of Gram Panchayat Dabhel:

On exclusion of the above local areas/villages/group of villages/falias from the territorial jurisdiction of Dabhel Group Gram Panchayat, the Administrator of UT of Daman & Diu, after making such inquiries as deemed necessary and in exercise of his powers under sub-section (1) of section 3 of the Daman & Diu Panchayat Regulation 2012, is pleased to declare local areas comprising of the following villages/group of villages/falias as separate Panchayat areas for the purpose of the said Regulation and specify their Headquarters as indicated against each. Further, in exercise of his powers under sub-section (2) of section 3 of the said Regulation the Administrator is pleased to constitute separate Gram Panchayat as named below for the Panchayat areas indicated against each;


