# DRAFT REPORT OF REHABILITAION & RESETTLEMENT SCHEME

It was notified by Collector, Diu, UT Administration of Daman & Diu vide Preliminary Notification No. 65-05-LAQ-/2018-19/927 dated 10/09/2019 that the lands described in the schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of Promenade Development for Diu Town from Diu Bus Station up to Fort, Diu.

The report dated 21/11/2019 received from the Mamlatdar, Diu mentions that livelihood of land holders at Sr. No. 3, 6 & 10 are directly dependent on their lands as they are living in the said residential houses, also Sr. No. 3, 9 & 10 are having their business on their properties i.e. Restaurant and Shops and Sr. No. 5 is a Social institution wherein local peoples of Diu District are doing prayers in morning and evening, Sr. No. 1, 2, 4, 7, and 8 of the said area are not directly dependent on the land which is to be acquired. The present condition as observed by the Rehabilitation and Resettlement Committee dated 20/11/2019 found that land at Sr. No. 3, 6, 9 & 10 are using for residential and business purpose and Sr. No. 5 for Social Institution and the land at Sr. No. 4 and 10 are using for agriculture purpose and the land at Sr. No. 1, 2, 7 and 8 neither use for residence nor for business activity carried out by the family members of land owners. At present there are only ten parcels of lands are affected in land acquisition totally admeasuring 5533.00 sq.mts. for Promenade Development for Diu Town from Diu Bus Station up to Fort, Diu.

This summary of Rehabilitation & Resettlement is made under the provisions of Section 16(2) of the Right to Fair Compensation and transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013 to whomsoever it may concern) is as below:-
