**NOTIFICATION**

In exercise of the powers conferred by Section 22 of the Building & Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 and in partial modification of the Notification No. LE/LI/DMN/Est-2(4)/2018/581 dated 21/03/2018, the Daman & Diu Building and Other Construction Workers Welfare Board hereby amend the Welfare Schemes formulated under this Act as under :

- (i) The Scheme No.(5) – “Grant of Purchase of Tools / Protective Gear” shall be amended as under:-

(5) – Grant of Purchase of Tools / Protective Gear :- The Deputy Commissioner (Labour) may sanction the grant for purchase of Tools / Protective Gear for an amount not exceeding Rs. 10,000/- (Rupees Ten Thousand Only) once in 5 years to those who have completed 6 months of the membership and who remit contribution regularly, and not completed 55 years of age.

An application in the prescribed Form VI shall be submitted to the Deputy Commissioner (Labour) for this benefit.”

- (ii) In Scheme No. (8) – “Medical Assistance and Wage Loss to the Beneficiaries”, the clause (a) shall be amended as under :-

(a) The Deputy Commissioner (Labour) may sanction financial assistance to the beneficiaries who are hospitalized. An amount not exceeding Rs. 10,000/- may be sanctioned in a stretch. The workers will be allowed to avail this benefit w.e.f. 17.10.2018.

The application shall be submitted in the prescribed form – IX to the Deputy Commissioner (Labour), Daman and the amount shall be sanctioned if he is satisfied with the case.

(iii) The following new scheme is added after the existing 14 schemes:-

“(15) Festival/Travelling Allowance :- The Deputy Commissioner may sanction the reimbursement of the actual expenses incurred by the beneficiaries for travelling in Non-AC Buses and Sleeper Class train, who are visiting their Native Place. Provided that the benefit will be available for travel during holi, Diwali or any other major festival only.

The application shall be submitted for availing the Festival/Travelling Allowance in the prescribed Form – XVII to the Deputy Commissioner (Labour), Daman alongwith a copy of tickets (Railway / Buses etc) and the amount shall be sanctioned if he is satisfied with the case.”
