(2) The First Party – Company is hereby directed to pay amount of Rs. 70,000/- towards gratuity, bonus and R.C. etc. to the Second Party – Claimant within 30 days from the date of order or award, failing which award amount carry interest @ of 8% per annum from the date of reference till actual realization of the amount and (3) Copy of award be sent to the concerned office for publication of award in the government official gazette as per the provisions of law.

1. The Government – Administrator of U.T. Daman and Diu, Daman through Deputy Secretary, Department of Labour and Employment, Daman has been referred the reference of industrial dispute under section 10(1) (d) read with section 12(5) of the Industrial Dispute Act in between the First Party – Company and Second Party – Claimant regarding leave with wages and holidays, bonus, profit sharing, provident fund and gratuity of Rs. 9,85,161/which fall in third schedule of the Industrial Dispute Act to this Industrial Disputes Adjudication Tribunal for adjudication and submit award with vide its order dated 23/10/2015 due to the Conciliation Officer submitted conciliation failure report dated 27.08.2015 under section 12(4) of the Industrial Dispute Act thereby no settlement is arrived regarding the industrial dispute between both the parties.

- 2. The reference of industrial dispute in between the First Party-Company and Second Party Claimant coming on this 6th day of December, 2019 for final disposal before V. P. Patkar, Presiding Officer, Industrial Disputes Adjudication Tribunal, Daman in the presence of Smt Nilam Patel Advocate for the First Party-Company and Shri Sanjay Patel Advocate for the Second Party-Claimant. The Second Party-Claimant claimed Rs. 9,85,161 regarding leave C.L. and P.L. salary, bonus, gratuity and notice, etc. respectively as the claimant No.1 out of the Second Party-Claimants claimed Rs. 1,32,645, the claimant No. 2 claimed Rs 1,76,703, the claimant No. 3 claimed Rs 1,70,409 who died through his wife, the claimant No. 4 claimed Rs 1,20,057, the claimant No. 5 claimed Rs 1,38,939, the claimant No. 6 claimed Rs. 1,95,585 and claimant No. 7 claimed Rs.50,823 against the First Party Company.
- 3. Both the parties settled the dispute and executed settlement agreement Exh.26 and the First Party-Company agreed to Pay amount Rs. 4,95,000 to the Second Party-Claimants respectively which is mentioned before their names in the settlement agreement as the claimant No. 1 out of the Second Party-Claimants, Rs. 75,000, the Claimant No. 2 Rs. 80,000, the claimant No. 3 Rs. 80,000, the claimant No. 4 Rs. 75,000, the claimant No. 5 Rs.75,000, the claimant No. 6 Rs. 80,000 and the claimant No. 7 Rs. 30,000 and the Second party-Claimants agreed to take this amount from the First Party Company.
- 4. And in view of settlement agreement the judgment passed on the referred reference and it is ordered and awarded that (1) The claim of Second Party Claimant is partly allowed with no order as to costs, (2) The First Party Company is hereby directed to pay amount to the Second Party Claimants as amount of Rs. 75,000 to the claimant No.1 Arvind Gayakwad, Rs. 80,000 to the Claimant No. 2 Sukar Chodhary, Rs. 80,000 to the claimant No. 3 Gangaram Gavli more particularly to his wife Sudhiben Gavli, Rs. 75,000 to the claimant No. 4 Ganpat Bhoya, Rs. 75,000 to the claimant No. 5 Dhanesh Nikuliya, Rs. 80,000 to the claimant No. 6 Rama Anaju and Rs. 30,000 to the claimant No. 7 Kamlesh Pandu within 30 days from the date of order or award, failing which award amount carry interest @ of 8% per annum from the date of reference till actual realization of the amount. (3) Copy of award be sent to the concerned office for publication of award in the government official gazette as per the provisions of law.
