NOTIFICATION

No. 7-5/EC/DD/2019: Whereas, the last delimitation of wards of District Panchayat, Daman, in UT of Dadra & Nagar Haveli and Daman & Diu was notified by the UT Administration of Daman & Diu vide Notification No. 5/49/PRI/(DELI-DIST.PAN)/2014-15/115 dated 6th September, 2015.

And whereas section 55 (3) of the Daman and Diu Panchayats Regulation, 2012 states, that 'the seats in the District panchayat shall be filled by persons chosen by direct election from the wards in such manner that the ratio between the population of each constituency and the number of seats allotted to it shall so far as practicable be the same throughout the District Panchayat area.'

And whereas rule 3 (1) of the Daman & Diu Panchayats (Election Procedure) Rules, 2014, states that subject to the provisions of section 12 & 55 of the Regulation, the Election Commission shall distribute the seats assigned to each Gram Panchayat, and District Panchayat to single member territorial wards and delimit them on the basis of the latest census figures, having regard to the following provisions, namely:-

(a) 'all words shall, as far as practicable, be geographically compact areas, and in delimiting them regard shall be had to physical features, existing boundaries of administrative units, facilities of communication and public convenience;

And whereas the number of seats for the District Panchayat, Daman have been determined by the Administrator, Dadra & Nagar Haveli and Daman & Diu vide Notification No. BDO/DMN/NEWGPS/WARDS/Part-2/27/2019/e-153905 dated 11.06.2020 increasing total number of seats from 12 to 16;

Now, therefore the Election Commission (UTs) draws the boundaries of wards of District Panchayat, Daman in exercise of powers under section 55 (3) of the Daman & Diu Panchayat Regulation, 2012 read with the 3 (1) & (2) of the Daman & Diu Panchayats (Election procedure) Rules, 2014, and hereby publishes its proposal for the delimitation of all

wards of District Panchayat, Daman as specified in the Annex appended to this notification for inviting suggestions and objections in this regard by 25th June, 2020;

Any objection or suggestion thereto should be submitted to the under mentioned officers either personally or by other means between 10.00 a.m. and 4.00 p.m. on all working days not later than 25th June, 2020. All suggestions or objections received after this date and time will be considered:-

- (i) The Secretary (PRI)/Director of Panchayat & Municipal Elections, UT Administration of Dadra & Nagar Haveli and Daman & Diu, secretariat, Moti Daman
- (ii) The Joint Secreatary (PRI)/Jt. Director of Panchayat & Municipal Elections, UT Administration of Dadra & Nagar Haveli and Daman & Diu, secretariat, Moti Daman

Detailed maps showing the extent of each ward of District Panchayat, Daman, shall remain available for inspection free of charge for the same period from the date of publication of this notification in the offices of the aforesaid officers.
