The MBBS seats under EWS quota shall be filled as per admission guidelines published vide No.DMHS/Med.Edu./2020-21/M.C/95/6970 dated 08/08/2020 in forthcoming academic year 2020-21. (Copy enclosed).

The Mamlatdar of the respective districts shall issue the Income & Assets Certificate for Economically Weaker Sections (EWSs) in UT of Dadra & Nagar Haveli and Daman & Diu in the prescribed format as per the guidelines issued by the Ministry of Personnel, Public Grievance and Pensions, Department of Personnel & Training, O.M. F.No.36039/1/2019-Estt.(Res) dated 19th January, 2019 and 31st January, 2019 and U.T. Administration's Notification No. 6/115/2019-PER/495 dated 26/06/2019.
