## NOTIFICATION

**No. PCC/DDD/RR/2020-21/273**

**Dated 5.10.2020**

In exercise of powers conferred under clause (e) of sub section (2) of section 64 of Water (Prevention and Control of Pollution) Act, 1974, the Administrator of Union Territory of Dadra & Nagar Haveli and Daman & Diu in consultation with the Pollution Control Committee (PCC) hereby makes the following rules namely:

### The Rules

- 1 Short Title : These Rules may be called the Appointment of Chairman and Member Secretary of the Pollution Control Committee of Dadra & Nagar Haveli and Daman & Diu (DNH&DD) Rules,2020
2. Appointment of Chairman and Member Secretary:
  - (I) No person shall be appointed by the UT Administration of Dadra & Nagar Haveli and Daman & Diu as Chairman, Pollution Control Committee (PCC) of Dadra & Nagar Haveli and Daman & Diu unless he possesses
    - (a) Special knowledge or practical experience in respect of matters relating to environmental protection or
    - (b) Knowledge and experience in administering institutions dealing with environmental protection

(II) No person shall be appointed by the UT Administration of Dadra & Nagar Haveli and Daman and Diu as Member Secretary, Pollution Control Committee (PCC) of Dadra & Nagar Haveli and Daman & Diu unless he possesses the desired qualification, knowledge and experience in environmental protection,

3. The terms and conditions for appointment to the post of Chairman and Member Secretary shall be as follows.

(a) Chairman

1.	Scale of Pay:	Level 15 in the) Pay Matrix of the 7 <sup>th</sup> pay Commission.
2.	Method of Appointment:	Direct Recruitment on contract basis/ Nomination/Transfer or Deputation
3.	Essential qualification and other Conditions:	1. A person shall not be eligible to be nominated as chairman unless (a) possesses Post graduate Degree in Science relating to environment or Degree in Engineering, in a discipline relating to environment from a recognized University or institute and (b) has special knowledge and ten years of experience relating to environment protection, including industrial pollution mitigation or waste water treatment or air pollution control devices and rendered twenty years of services or (c) has been a member of All India Service in the service of central or any state Government/UT Administration of the rank and equivalence of secretary in the pay matrix of level 14 and has special knowledge or practical experience in matters relating to environmental protection or experience in administering institutions dealing with matters related to the

		environment or (d) has been in the service of central government or state government or public sector undertaking or autonomous body or statutory body and (i) holds an analogous post basis in the parent department; or (ii) has three years or regular service in the grade rendered after appointment thereto on regular basis in the level 14 of Pay band Matrix or equivalent in the parent cadre or department and possess the qualifications (iii) and experience for nomination under clause (a) above.
4.	Desirable Qualification:	Has a Doctoral Degree in Environmental Management and Experience from a recognized University or Institute and excellent record of peer reviewed research publications.
5.	Age Limit & Tenure	Not more than 60 years
6.	Tenure	3 years

*An officer working under the Central Government or State Government or a public sector undertaking or a University or an autonomous body or statutory body selected for nomination as the Chairman under clause (a) of Sub- Section (2) of section 4 of the Act, shall be considered for nominations as the chairman on deputation basis.*

*Explanation :-Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department or the Central Government shall ordinarily not exceed three years.*

3	Essential qualifications and other conditions :	<p>Possess degree in science or degree in engineering from a recognized institute or university or its equivalent, with knowledge and experience relating to environment and</p> <p>a serving officer from All India Service or in any services of the Central or State Government</p> <p>or public sector undertaking or university or Government Research Institute or Autonomous or Statutory body</p> <p>who is holding analogous post on regular basis in the parent cadre or department or in the pay matrix of level 13 or</p> <p>with two years of regular service rendered in the grade after appointment thereto on regular basis in the pay level of 12 in the pay matrix of the central Government or its equivalent in the state government or equivalent in the parent cadre or department or</p> <p>six years of service in the grade rendered after appointment thereto, on regular basis in the pay level of 11 in the pay matrix of the central government or equivalent in the cadre or department</p>

4	Desirable Qualification	Ph.D. in Science relating in Environment or M.Tech in Engineering in discipline relating to Environment from recognized University or institute equivalent.
5	Age limit	not more than 56 years
6	Tenure	5 years

*An officer working under the Central Government or State Government or a public sector undertaking or a University or an autonomous body or statutory body selected for nomination as Member Secretary under clause (a) of Sub- Section (2) of section 4 of the Act, shall be considered for nominations as member secretary on deputation basis.*

*Explanation :- Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department or the Central Government shall ordinarily not exceed three years.*
