Further, in exercise of the power conferred by sub-section (4) of the section 4 of the said Act. the officers specified in column 3 of the above table are further delegated the powers for appointing Census Officers within their respective jurisdictions and are authorized to sign declaration under provision of Sub-Section (3) of Section 4 of Census Act, 1948.
- 3. Further, in Exercise of the power conferred by sub-section (1) of the section 6 of the said Act, the officers specified in column 3 of the above table are appointed as competent officers who may by written orders direct the persons mentioned in clauses (a) to (f) to perform such duties of the Census officers.
- 4. As per the provisions of Section 11 of the Census Act, 1948, any Census Officer or any person lawfully required to give assistance towards the taking of Census and who refuses to perform any duty allotted to him/her under this Act or any rule made there under, or any person who hinders or obstructs another person in performing any such duty, shall be punishable with fine up to one thousand rupees or in case of a conviction shall also be punishable with imprisonment which may extend to three years.

ORDER (u/s 144 of Cr.P.C.)

WHEREAS, it has come to the attention of the undersigned that a noval virus Coronavirus has surfaced in the East Asia which is infecting human beings in the countries like China, Hongkong, Singapore and Thailand;

AND WHEREAS, the said Coronavirus being contagious need to be contained from spreading in this District;

AND WHEREAS, for the above mentioned purpose, Health Department is the Nodal Department;

AND THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli and Daman & Diu, Silvassa, hereby order as follows.

- All the Resorts and Hotels in this territory shall report to Health Department on toll free Emergency number <u>104</u>, regarding any customer (whether India or foreigner), who has traveled from China, Hong Kong, Singapore and Thailand after 15th January 2020;
- All the Industries in this territory shall report regarding any employee, consultant or labourer, who has traveled from China, Hong Kong, Singapore and Thailand after 15th January 2020;
- 3. The Police Department in this territory shall report regarding any person who has traveled from China, Hong Kong, Singapore and Thailand after 15th January 2020;
- 4. The Director of Medical and Health Services, Dadra & Nagar Haveli and Daman & Diu, Silvassa, shall prepare a Quarantine Room so as to be prepared to contain the affected persons from the said coronavirus in case needed. It shall regularly monitor the situation in this regard proactively involving every stakeholder;
- 5. The Director of Medical and Health Services, Dadra & Nagar Haveli and Daman & Diu, Silvassa, shall submit a status report daily positively by 1000 Hours regarding the number of such persons examined, their health status and action taken;
- The general public is also directed to report regarding any person who has traveled from China, Hong Kong, Singapore and Thailand after 15th January 2020 to the above mentioned authorities.

This Order shall come into force immediately from the date of issue and shall remain in force until 60 days from this date of issue.

As the Order cannot be served individually, the Order is put in the public domain for information and necessary action.
