> Pradhan Mantri Fasal Bima Yojana-PMFBY Continuation thereof and Declaration of Notified Insurance Unit, Cut-off dates etc. for Kharif, 2020.

Administration of Dadra and Nagar Haveli and Daman and Diu (Department of Agriculture),

 - (2) Operational Guideline Pradhan Mantri Fasal Bima Yojana.

Preamble:

In Order to make Crop Insurance Simpler and Cheaper for Farmers and to provide them Better Insurance Services, Govt. of India has Introduced "Pradhan Mantri Fasal Bima Yojna-PMFBY" from Kharif 2016 Season onwards.

In pursuance of the administrative approval, along with the operational guidelines of Pradhan Mantri Fasal Bima Yojna- PMFBY circulated by Government of India, vide letter dated 23-02-2016(read ref. no.-1 & 2) UT of Dadra and Nagar Haveli and Daman and Diu has accepted for Implementation of Pradhan Mantri Fasal Bima Yojna- PMFBY for the year 2019-20 and 2020-21.

The issue of implementation of the Pradhan Mantri Fasal Bima Yojna- PMFBY and declaration of defined areas along with major and minor crops for Kharif 2020 season and other related issues were discussed at length by the SLCCCI meeting held on 18/07/2019 at Secretariat, Silvassa.

Accordingly, it was decided to implement PMFBY for Kharif -2020 and as per the guidelines, the UT Administration of Dadra and Nagar Haveli and Daman and Diu has to notify by way of certain things i.e. coverage of farmers, defined crops, defined areas, Sum insured, indemnity level, seasonality disciplines, threshold yield etc., which were under consideration of the Government.

RESOLUTION: -

As per Operational guidelines of PMFBY and decisions taken in the meeting of SLCCCI, the UT Administration of Dadra and Nagar Haveli and Daman and Diu is pleased to implement the Pradhan Mantri Fasal Bima Yojna- PMFBY during Kharif 2020 season. UT Administration of Dadra and Nagar Haveli and Daman and Diu decide the following under this scheme for the purpose.

(1) Farmers covered

All farmers including sharecroppers, tenant farmers growing the notified crops in the notified area are eligible during Kharif 2020 season on the following basis:

(A) On Compulsory Basis:

All farmers availing Seasonal Agriculture Operations (SAO) loans from Banks/Financial Institutions (i.e. loanee farmers) within the stipulated period for the notified crops would be covered compulsorily.

(B) On Voluntary Basis

All other farmers growing insurable notified crop/crops in the notified Defined Area and not availed Seasonal Agricultural Operations (SAO) loans (i.e. Non-Loanee Farmers) but opt for the scheme. The non-loanee farmers are required to submit necessary documentary evidence of land records prevailing in the UT Administration of Dadra and Nagar Haveli and Daman and Diu (Records of Right (RoR), Land possession Certificate (LPC) etc.) and/ or applicable contract/ agreement details.

(C) Special efforts shall be made to ensure maximum coverage of SC/ST/Women farmers under the scheme.

(2) Crops covered in PMFBY for Kharif, 2020 are:

As decided by SLCCCI, following 06 (Six) Crops shall be covered under PMFBY for Kharif, 2020 in the UT of Dadra and Nagar Haveli and Daman and Diu

1.	Paddy
2.	Ragi (Nagli)
3.	Tur
4.	Urid
5.	Bajara
6.	Juwar

(3) Defined Areas for the Kharif, 2020

As decided by SLCCCI, the defined area for Major/Minor crop would be entire UT of Dadra and Nagar Haveli and Daman and Diu for Kharif, 2020 season comprising of 38 Gram Panchayats and 03 Municipal Area. Entire UT of Dadra and Nagar Haveli and Daman and Diu will be considered as one cluster.

(4) Crop wise sum insured, indemnity level and premium rates for the farmers for Kharif, 2020

Crop wise sum insured, indemnity level and premium rates for the farmers for both loanee and Non-loanee farmers for Kharif, 2020 would be as under:

(A) <u>Sum Insured:</u>

The Sum Insured (SI) per hectare for both loanee and non-loanee farmers would be the same and equal to the Scale of Finance for the crops as fixed by District Level Technical Committee (DLTC). Looking to the notified crops, the Sum Insured of notified areas per hectare is given as below;

1.	Kharif Paddy Crop (Irrigated)	Rs. 42,500/- Per Hectare
	Kharif Paddy Crop (Un-Irrigated)	Rs. 15,000/- Per Hectare
2.	Ragi (Nagli)	Rs. 20,000/- Per Hectare
3.	Tur, Urid	Rs. 25,000/- Per Hectare
5.	Bajara	Rs. 40,000/- Per Hectare
6.	Juwar	Rs. 30,000/- Per Hectare

(B) Indemnity Level:

The UT of Dadra and Nagar Haveli and Daman and Diu is a Single District cum Block Administration. The indemnity level would be at moderate level of 80% during Kharif, 2020 for the entire UT of Dadra and Nagar Haveli and Daman and Diu.

(C) <u>Premium rates for the farmers (Both loanee and non-loanee)</u>:

Premium rates for farmers in Kharif 2020 for the notified crops are as under;

Sr. No.	Season	Crops	Maximum Insurance Charges payable by farmer (% of Sum Insured)
1.	Kharif	Cereal crops like Paddy,Bajara,Juwar millets like Ragi(Nagali) and Pulses like Tur and Urid	2.0% of SI or Actuarial rate, whichever is less

All the Banks/financial institutions are hereby directed to collect farmer's total share of premium as per the rate mentioned above with respect to sum insured. The amounts so collected will have to be transferred to the respective Implementing Agency as may be finalized later on.

(5) <u>Seasonality discipline</u>

The following seasonality discipline will be observed in the UT of Dadra and Nagar Haveli and Daman and Diu for Kharif, 2020 Season.

(A) Submission of insurance proposal by the farmers to the Banks/financial institutions and consolidated declaration by Banks to implementing agency as per given below:

NOTE: The Respective Banks should deduct the premium of loanee farmers within a cut off date and it is mandatory to make online entry on portal as per the document submitted by the farmers at the time of approval of loan and get sign of respective farmers on printed copy of application. The portal will be opened for financial Intuition as mentioned cut- off dates as above.

NOTE: If the cut-off dates falls on Public holiday/Bank holiday declared under negotiable instrument act, then next working day shall be the cut-off date.

Any change in crop plan should be brought to the notice of the bank within one week of sowing by the loanee farmers. Farmers covered, on voluntary basis, can buy insurance before actual sowing/planting, based on advance crop planning. However, for any reason if a farmer changes the crop planned earlier, he should intimate the change to insurance company, at least 30 days before cut-off date for buying insurance through financial institution/channel partner/insurance intermediary/directly; as the case may be, along with difference in premium payable, if any, accompanied by sowing certificate issued by concerned village Authority. In case the premium paid was higher, insurance company will refund the excess Premium

(B) Cut-off dates for submission of yield data to concerned Insurance Company.

Fixation of cut-off dates for submission of yield data to concerned insurance company shall be as the following schedule.

(C) The Cut-off dates of different risks as mentioned in PMFBY operational guidelines.

i) Prevented sowing :

As per the operational Guidelines of PMFBY para no. XIII, to provide insurance cover to farmers in case of widespread incidence of eligible risks (para IV.1.a) affecting major crops notified, if more than 75% of area sown in a notified Insurance Unit at early stage leading to total loss of crop or the farmers are not in a position to either sow or transplant the crop. The precondition for this cover is issuance of notification of the scheme before commencement of normal sowing process and details of insurance coverage from banks should have been advised to Insurance

Company. District Level Monitoring Committee (DLMC) will notify the crop wise normal area sown at the beginning of the season within 15 days and provide to Selected Insurance Company with intimation to SLCCCI.

ii) Cut-off date for on Account Payment of Claims due to Mid-Season Adversity:

To provide immediate relief to insured farmers in case of adverse seasonal conditions during the crop season viz. floods, prolonged dry spells, severe drought etc., wherein expected yield during the season is likely to be less than 50% of Threshold yield. If adversity occurs within 15 days before the normal harvest time, this provision will not be invoked.

iii) Cut-off date for Post harvest Losses:

To provide for assessment of yield losses on individual plot basis in case of occurrence of cyclone, cyclonic rains and unseasonal rains throughout the country resulting in damage to harvested crop lying in the field in 'cut and spread' condition up to maximum period of two weeks (14 days) from the normal harvesting for sole purpose of drying.

If adversity occurs withinn 15 days before the normal harvest time, this provision will not be invoked. The normal harvest time of all notified crops is as below;

(6) Cluster for implementation of PMFBY:

For implementing PMFBY in the UT of Dadra and Nagar Haveli and Daman and Diu, all 38 Gram Panchayats and 03 Municipal Areas will be the Cluster.

(7) Implementing Agency for Kharif, 2020:

(A) The selection of insurance company from the empanelled insurance companies to act as IA will be done by tender process.

(B) The selection of IA from the empanelled Insurance companies shall be done based on the lowest weighted premium quoted by an empanelled Insurance Company for all notified crops within the cluster of districts.

(8) Nodal Agency for PMFBY:

The Office of Deputy Director Agriculture/ Zonal Agriculture Office, Dadra and Nagar Haveli and Daman and Diu will be work as a Nodal Agency for PMFBY.

(9) Threshold yield:

Threshold yield will be decided and declared separately.

(10) Crop Cutting Experiments:

The Crop Cutting Experiments will be conducted as per the guideline of General Crop Estimation

Surveys (GCES).

- (a) Where the CCEs not conducted in the notified Insurance Unit due to unavoidable circumstances, adopting yield estimate of next higher unit will be considered for the Calculation of Claims.
- (b) Banks as well as the concerned Insurance Company should verify crop and area sown details given by the loanee and non-loanee farmers by using their own resources.
- (c) The Director of Agriculture, State Level Bankers Committee (SLBC), Lead Banks, District Central Cooperative Banks, District Officers and Concerned Insurance Company should take necessary action to ensure the effective implementation of the scheme as per guidelines of PMFBY.



WHEREAS, the then Commissioner of Food safety under Section 30 of the Food Safety and Standards Act, 2006 issued Notification in the interest of public health, imposing a complete ban on the manufacture, storage, distribution and/or sale of chewing of Tobacco with whatever names it may known, sach as Zarda, Gutkha and Pan Masala, known by any names, containing either tobacco and/or nicotine or Magnesium Carbonate as an ingredient as Gutkha or Pan Masala, with final product available in market in the whole UT of Dadra & Nagar Haveli & Daman & Diu has been prohibited in whole UT of Dadra & Nagar Haveli & Daman and Diu;

2. AND WHEREAS, in the research conducted by various institution, it is observed that, due to consumption of Zarda, Gutkha (Chewing Tobacco) there are chances of oral cancer. It is further revealed that chewing of Tobacco leads to oral sub-mucous fibrosis;

3. AND WHEREAS, Zadra, Gutkha (Chewing Tobacco or known by any name) are articles of food which contain tobacco and/or nicotine or Magnesium carbonate as ingredients and consumption of such products is injurious to health and this contravenes the provision Restriction 2.3.4 of the Food Safety and Standards (Prohibition & restriction on sales) Regulations, 2011.

4. AND WHEREAS, with reference to order dtd.: 03/04/2013 passed by the Hon. Supreme Court, the Ld. Additional Solicitor General invited Court attention to notification issued by the Government of 23 States and the Administrator of 5 Union Territories for imposing complete ban on Gutkha and Pan Masala with Tobacco and/or nicotine and then stated that notwithstanding the ban, the manufacturers have devised a subterfuge for selling Gutkha and Pan Masala in separate pouches and in this manner the ban is being flouted and thereafter, Hon'ble Court has passed order to issue notification in term of 2006 Act in respect of total

compliance of ban imposed on manufacturing and sale of Gutkha and pan masala with tobacco and/or nicotine;

5. NOW THEREFORE, I, Dr. A. Muthamma, The Commissioner of Food Safety, UT of Daman & Diu, in exercise of the powers confirmed by clause (a) sub-section (2) of section 30 of the Food Safety and Standard Act, 2006 (Act No. 34 of 2006), in the interest of public Health, hereby impose a complete ban on "Gutkha & Pan Masala know by any names containing Tobacco and/or nicotine as an ingradient available in the market and any other products marketed separately to constitute as Gutkha or pan Masala as final product". As the direction given by Hon'ble Court only in respect of Gutkha and Pan Masala with tobacco and/or nicotine, and not in respect of all Pan Masala in the market, in the whole of U.T. of Dadra & Nagar Haveli & Daman & Diu for a further period w.e.f. 01/01/2020 to 31/12/2020.

The committee shall have tenure of three years and the appointment of members shall be co-terminus with the tenure of the committee. The Selection Committee shall perform its duties as per provisions of Juvenile Justice (Care and Protection of Children) Act, 2015 and the Juvenile Justice (Care and Protection of Children) Rules, 2016. The major duties of Selection Committee are detailed as under:-

- 1. Remuneration of Rs. 10,000/- shall be paid to the Chairperson of the Selection Committee per sitting and also the Chairperson shall be entitled for Travel Allowance (T.A.) and Dearness Allowance.
- 2. The Selection Committee shall evaluate the candidates on the basis of qualifications, experience of working with children and personal interaction with the candidate.
- 3. The Selection Committee shall, on the basis of the evaluation procedure and criteria, select and recommend a panel of names in order of merit to the State Government for appointment as Members of the Juvenile Justice Board or Chairperson or Members of the Child Welfare Committee as the case may be.
- 4. The Selection Committee shall also prepare a list of names for the Child Welfare Committee and Juvenile Justice Board to fill up vacancies, which may arise during the tenure of the Child Welfare Committee and Juvenile Justice Board respectively.

Preface: -

Vide notification no. LAQ/EGSRS&VGSRS/Bonta/1/2019/602 Dated 28/12/2019 land of village Bonta was notified u/s 11(1) of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for Integrated water management plan for Bonta Junction UGSRS & ESRS. Collector is the land acquisition collector under the RFCTLARR Act 2013. Vide above mentioned Notification, Resident Deputy Collector(S) was appointed as the Administrator under sub section (1) of Section 43 of the said act for Rehabilitation and Resettlement of affected families due to acquisition of the said land as mentioned above. As per section 16 of RFCTLARR Act 2013, Preparation of Rehabilitation and Resettlement Scheme by the Administrator should be done and the same is reproduced as below: -

16. Preparation of Rehabilitation and Resettlement Scheme by the Administrator

- Upon the publication of the preliminary notification under sub-section(1) of section 11 by the collector, the Administrator for Rehabilitation and Resettlement shall conduct a survey and undertake a census of the affected families, in such manner and within such time as may be prescribed, which shall include —
 - (a) Particulars of lands and immovable properties being acquired of each affected family;

The Administrator shall, based on the survey and census under sub-section (1), prepare a draft Rehabilitation and Resettlement Scheme, as prescribed which shall include particulars of the rehabilitation and resettlement entitlements of each land owner and landless whose livelihoods arc primarily dependent on the lands being acquired and where resettlement of affected families is involved —

- (i) A list of Government buildings to be provided in the Resettlement Area;
- (ii) Details of the public amenities and infrastructural facilities which arc to be provided in the Resettlement Area.
- 3. The draft Rehabilitation and Resettlement scheme referred to in sub-section (2) shall include time limit for implementing Rehabilitation and Resettlement Scheme.
- 4. The draft Rehabilitation and Resettlement scheme referred to in sub-section (2) shall be made known locally by wide publicity in the affected area and discussed in the concerned Gram Sabhas or Municipalities.
- 5. A public hearing shall be conducted in such manner as may be prescribed, after giving adequate publicity about the date, time and venue for the public hearing at the affected area:

Preface: -

Vide notification no. LAQ/Checkdam-Causeway/Athola/30/2018/603/19 Dated 28/12/2019 land of village Athola was notified u/s 11(1) of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for Construction of Checkdam cum Causeway near village Athola on Pipariya River. Collector is the land acquisition collector under the RFCTLARR Act 2013. Vide above mentioned Notification, Resident Deputy Collector(S) was appointed as the Administrator under sub section (1) of Section 43 of the said act for Rehabilitation and Resettlement of affected families due to acquisition of the said land as mentioned above. As per section 16 of RFCTLARR Act 2013, Preparation of Rehabilitation and Resettlement Scheme by the Administrator should be done and the same is reproduced as below: -

- 16. Preparation of Rehabilitation and Resettlement Scheme by the Administrator
 - Upon the publication of the preliminary notification under sub-section(1) of section 11 by the collector, the Administrator for Rehabilitation and Resettlement shall conduct a survey and undertake a census of the affected families, in such manner and within such time as may be prescribed, which shall include —
 - (a) Particulars of lands and immovable properties being acquired of each affected family;
 - (b) Livelihoods lost in respect of land losers and landless whose livelihoods are primarily dependent on the lands being acquired;
 - (c) A list of public utilities and Government buildings which are affected or likely to be affected, where resettlement of affected families is involved;
 - (d) Details of the amenities and infrastructural facilities which are affected or likely to be affected, where resettlement of affected families is involved; and
 - (e) Details of any common property resources being acquired.
 - 2. The Administrator shall, based on the survey and census under sub-section (1), prepare a draft Rehabilitation and Resettlement Scheme, as prescribed which shall include particulars of the rehabilitation and resettlement entitlements of each land owner and

landless whose livelihoods arc primarily dependent on the lands being acquired and where resettlement of affected families is involved —

- (i) A list of Government buildings to be provided in the Resettlement Area;
- (ii) Details of the public amenities and infrastructural facilities which arc to be provided in the Resettlement Area.
- 3. The draft Rehabilitation and Resettlement scheme referred to in sub-section (2) shall include time limit for implementing Rehabilitation and Resettlement Scheme.
- 4. The draft Rehabilitation and Resettlement scheme referred to in sub-section (2) shall be made known locally by wide publicity in the affected area and discussed in the concerned Gram Sabhas or Municipalities.
- 5. A public hearing shall be conducted in such manner as may be prescribed, after giving adequate publicity about the date, time and venue for the public hearing at the affected area:

As per chapter VI, Procedure and manner of Rehabilitation and Resettlement-Section 43 of RFCTLARR Act 2013, the undersigned has been appointed as the Administrator for drafting Rehabilitation and Resettlement scheme. This Rehabilitation and Resettlement scheme (R&R scheme) is being drafted in consonance with section 16, 17, 18, 19, 31, 41 & 42 (if applicable), 43, Second Schedule of RFCTLARR Act 2013 and Rules 7, 8, 9 (if applicable) 16, Form IV (if applicable) and Form VII of RFCTLARR (Compensation, Rehabilitation and Resettlement and Development Plan) Rules 2015.

As per the Section 3(k) of RFCTLARR Act 2013, "Displaced Family" means any family who on the account of acquisition of land has to be relocated and resettled from the affected area to the resettlement area. In the present case the land being acquired is Agriculture land for which compensation shall be paid as and when the Collector, Dadra and Nagar Haveli announces the Award. Therefore, it is evident that the affected family may not need relocation and resettlement because they are either not losing their complete house/ land or are left with some land after acquisition or in some cases they are having alternate Residential option. However, I am of the opinion no case for Resettlement is made out for the project affected families. I am of the opinion that the affected families may be considered for Rehabilitation only.

The Rehabilitation & Resettlement Scheme is prepared based on the Second Schedule (ELEMENTS OF REHABILITATION AND RESETTLEMENT ENTITLEMENTS FOR ALL THE AFFECTED FAMILIES (BOTH LAND OWNERS AND THE FAMILIES WHOSE LIVELIHOOD IS PRIMARILY DEPENDENT ON LAND ACQUIRED) IN ADDITION TO THOSE PROVIDED IN THE FIRST SCHEDULE).
