WHEREAS, a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Daman & Diu and Dadra & Nagar Haveli to proceed with acquisition process and the same has been approved by the Appropriate Government i.e. Administrator of Daman & Diu and Dadra & Nagar Haveli.

WHEREAS, vide Declaration No. LAQ/Med-Coll/P.I/26/2018/82/Rev(S) dated 04/03/2020, it was declared under the provision of Section 19 of the Land Acquisition and Rehabilitation Act that the said lands are required for the public purpose, and namely for the purpose of Construction of Medical College in village Sayli.
