NOTICE

WHEREAS, vide Preliminary Notification No. LAQ/High Speed Rail Project/Naroli-Dhapsa/4/2017/448/2018 dated 31/07/2018, it was Notified under section 11 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the land described in the schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of **Construction of Infrastructure project of Mumbai-Ahmedabad High Speed Rail Project (MAHSR)**;

WHEREAS, a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu to proceed with acquisition process and the same has been approved by the Appropriate Government i.e. Administrator of Dadra & Nagar Haveli and Daman & Diu;

WHEREAS, vide Declaration No. LAQ/High Speed Rail Project/Naroli-Dhapsa/4/2017/438/2019 dated 04/09/2019, it was declared under the provision of Section 19 of the Land Acquisition and Rehabilitation Act that the said lands are required for the public purpose, and namely for the purpose of Construction of Infrastructure project of Mumbai-Ahmedabad High Speed Rail Project (MAHSR);

WHEREAS, M/s Bhilosa Industries Pvt. Ltd. (BIPL) submitted undertaking dated 21.12.2018 and 26.12.2018 to National High Speed Rail Corporation Ltd. (NHSRCL) and agreed to the Terms and conditions of NHSRCL, with one of the condition that BIPL will transfer the land in Annexure- I to NHSRCL at Rs. 1/- along with consideration that NHSRCL will lease back the said land to BIPL for 99 years at the rent of Rs. 1/- and the said lease will be renewable upon request from BIPL;

WHEREAS, in connection with acquisition of land admeasuring 1400.00 sq.mtrs. for Construction of Infrastructure project of Mumbai-Ahmedabad High Speed Rail Project (MAHSR), the Administration of Dadra and Nagar Haveli intends to take possession of land, the particulars of which are given in the declaration u/s 19(1) of the Right to Fair compensation & Transparency in land Acquisition Rehabilitation and Resettlement (RFCTLARR) Act, 2013.

WHEREAS, under section 21 of the RFCTLARR Act, 2013, the Government intends to take possession of the land **in 30 days** from the date of issue of this Notice, and claims to compensations and rehabilitation and resettlement for all interests in the land, has to be submitted to the collector for disposal **within 30 days** from the date of issue of this Notice;

The details compensation on the land acquisition as per the **Annexure- I** is enclosed herewith;

WHEREAS, under sub section (1) & (2) of Section 22 of the said Act, the Collector may also require any such person to make or deliver to him a statement containing the name of every other person possessing any interest in the land or any part thereof as co-proprietor, mortgage, tenant or otherwise, and of the nature of such interest, and of the rents and profits, if any received or receivable on account thereof for three years next preceding the date of statement, every person required to make or deliver a statement under this section shall be deemed to be legally bound to do so within the meaning of section 175 and 176 of the Indian Penal Code (45 of 1860);

NOW THEREFORE, to facilitate causation of the above requirements, public notice is hereby served under section 21 of the RFCTLARR Act, 2013 that all persons having interest in the said land to appear personally or by agent or advocate before the collector, Dadra and Nagar Haveli on **08/08/2020** and to state in writing and signed by the party of his agent, the following:

- a) The nature of their respective interest in their land;

1.2 Roles and Responsibilities of Union Territory Level Approval and Monitoring Committee (UTLAMC) :-

- (a) The Union Territory Level Approval and Monitoring Committee (UTLAMC) will be responsible for consolidation of District Fisheries Plan and for preparation and approval of

the Annual Union Territory Fisheries Plan and recommending to the Department of Fisheries, Government of India/National Fisheries Development Board (NFDB), Hyderabad.

- (b) The UTLAMC will be responsible for implementation of the PMMSY at the Union Territory Level including its supervision and monitoring.
- (c) The UTLAMC would be assisted by the Union Territory Programme Unit (UTPU) for PMMSY.
- (d) The UTLAMC will undertake convergence of activities under PMMSY with activities/interventions other Schemes and programmes at the Union Territory level.
- (e) The UTLAMC will facilitate fostering bank linkages/ financial institutions to the beneficiaries under PMMSY.
