WHEREAS, vide Preliminary Notification No. LAQ/SMC/ Fly Over Bridges/Ring Road/11/2019/580 dated 12.12.2019, it was Notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the lands described in the Schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the Construction of Fly Over Bridges at Ring Road Junction A, B and G of village Silvassa, Amli and Samarvarni of Dadra and Nagar Haveli;

AND WHEREAS, as required under sub section (2) of section 15 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, No objection were received by the Department, and a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu to proceed with the acquisition process and the same has been approved;

AND WHEREAS, the Joint Measurement was conducted where it was found that few survey nos. were not included in Preliminary Notification dated 12.12.2019 due to sub-division of survey number. Accordingly, such land owners were served with a notice no. LAQ/Fly Over Bridges/Ring Road/11/2019/107/2020 dated 01.05.2020 stating that survey nos. and area mentioned in the notice is to be acquired for the said purpose and requested to submit objection if any, within ten days of issue

of the Notice, failing which it will be understood that there is No objection from the land owners or interested parties;

AND WHEREAS, an objection dated 08.06.2020 was received from Atmaram Suryavanshi stating his land was not notified and requested to notify his land and pay him with the compensation as per the market value;

AND WHEREAS, the objection was verified by PWD-II & Survey and Settlement Department, Silvassa by conducting a joint site inspection and submitted a report on 27.07.2020 along with area statement in which the land bearing survey no. 90/3p2 of Atmaram Vamanrao was included;

AND WHEREAS, No objections were received by the Department in regard of notice dated 01.05.2020, and a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu to proceed with the acquisition process and the same has been approved;

AND WHEREAS, the Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu is satisfied, on the basis of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the Rehabilitation and Resettlement Scheme shall be applicable because there are 102 number of families are getting affected due to acquisition;

NOW, THEREFORE, it is hereby declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said lands are required for the public purpose, namely for Construction of Fly Over Bridges at Ring Road Junction A, B and G of village Silvassa, Amli and Samarvarni of Dadra and Nagar Haveli.
