NOTIFICATION

Whereas, Rule 15 (1) of the Union Territory of Dadra and Nagar Haveli Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015 “*The term of the members of the Town Vending Committee, other than the Government officials who shall be members in ex-officio capacity, shall be five years from the date of their election or nomination, as the case may be*”.

Whereas, last elections to elect the members for Town Vending Committee in Silvassa (Silvassa Municipal Council) were held on 10th August, 2016 and the terms of elected members of Town Vending Committee is expiring on 11/08/2021.

And whereas, Rule 15 (2) of the Union Territory of Dadra and Nagar Haveli Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015, “*The process of electing or nominating, as the case may be, of the members shall be completed before the expiry of their term*”.

Now, therefore, in pursuance of the provision of Rule 13 clause (1) of the Union Territory of Dadra and Nagar Haveli' Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015, Silvassa Municipal Council hereby intends to conduct elections for the members of the Town Vending Committee representing the street vendors of the area under the jurisdiction of the Silvassa Municipal Council. Moreover, in pursuance of the provision of Rule 13 clause (2) of the Union Territory of Dadra and Nagar Haveli Street Vendors (Protection of Livelihood and Regulation

of Street Vending) Rules, 2015, Silvassa Municipal Council hereby appoints Shri Bhavesh K. Patel, Administrative Officer, SMC as Returning Officer, who will hold the election in the manner provided under the schedule appended to Union Territory of Dadra and Nagar Haveli, the Street Vendors (Protection of Livelihood and Regulation of Street Vending), Rules, 2015.

This order will come into immediate effect continue up to and including 31st Dec 2022 in the whole area of Daman (District).
