NOTIFICATION

In Partial modification to earlier Notification No. PCC/DMN/13-(Part IV)/98-99/2014-15/1199 dated 09.10.2015 related to banned category of industries (establishment/Operate) in the Union Territory of Dadra & Nagar Haveli and Daman & Diu due to their high pollution potential/manufacturing process/products which may endanger public health, safety and environment and in view of the pollution potential, technology available for effective mitigation, clean energy requirement, promotion of emission reductions for clean environment, the Administrator, Dadra & Nagar Haveli and Daman & Diu in exercise of powers conferred under section 5 of the Environment (Protection) Act, 1986, conferred vide notification No. SO 667 (E) dated 10.09.1992 hereby allow the following categories of industries for establishment and operations in the territory:

- 1. Industry or process involving metal surface treatment or process such as pickling/ electroplating/ paint stripping/ heat treatment using cyanide bath/ phosphating or finishing and anodizing / enamellings / galvanizing with ZLD facility
- 2. Automobile Manufacturing (integrated facilities) with ZLD facility
- 3. Manufacturing of lithium ion battery
- 4. Grain based distillery for production of ethanol only for blending purpose with ZLD facility
- 5. Milk Processing and Dairy products

Except for the industries mentioned as above, the industries falling under banned category as per notification dated 09.10.2015 will not be permitted to be established in order to protect the ecology, environment and fragile ecosystems of the territory. All other conditions stipulated vide earlier notification dated 9.10.2015 and 25.01.2021 shall remain unchanged.

This notification shall come into force with immediate effect.
