No. 7-17/EC/DD/2022: Whereas, the Administrator of the Union Territory of Dadra and Nagar Haveli and Daman and Diu has, by notification under Rule 23 of the Daman and Diu Municipalities (Elections) Rules, 1995, published in the Official Gazette on the 13th June, 2022, called upon all wards of the Diu Municipal Council to elect members to constitute a new Municipal Council;

And, whereas, in pursuance of the provisions of Rule 28 of the Daman and Diu Municipalities (Elections) Rules, 1995, the Election Commission for the Union Territory of Dadra and Nagar Haveli and Daman and Diu, vide its Notification No. 7-17/EC/DD/2022 dated the 13th June, 2022, appointed the dates for filing nominations, taking the poll, etc;
