Whereas, it appears to the appropriate Government that a total of **65608.00 Sq.Mtrs.** land is required in the Village **Marwad and Kathiria, Nani Daman, Daman District** for public purpose, namely, **Acquisition of land for extension of airfield facilities for Indian Coast Guard Air Station, Daman.**
