NOTIFICATION

In exercise of the powers conferred by the proviso to Article-309 of the Constitution, read with The Department of Personnel & Training OM No.AB-14017/61/2008-Estt.(RR), dated 24th March, 2009 and in supersession of the earlier Recruitment Rules, the Administrator of Daman and Diu is please to makes the following rules relating to recruitment to the General Central Service, Group "C" (Non-Gazetted, Non-Ministerial) Post of Driver cum Pump Operator in the Department of Fire and Emergency Services, Administration of Daman & Diu, (UT) namely :-

(1) SHORT TITLE APPLICATION AND COMMENCEMENT :

1. These Rules may be called Administration of Daman & Diu, Department of Fire & Emergency Services, Group "C" Non-Gazetted, Non-Ministerial, post of Driver cum Pump Operator, Recruitment Rules 2013.
2. They shall apply to the posts specified in Column-1 of the Schedule to these rules (herein after called the said schedule).
3. These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.

(2) NUMBER, CLASSIFICATION AND SCALE OF PAY :

The Number of posts, classification of the said posts and scales of pay attached thereto shall be as specified in column -2 to 4 of the Schedule to these rules : Provided that, the Administrator of Daman & Diu may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

(3) METHOD OF RECRUITMENT, AGE LIMIT AND OTHER QUALIFICATIONS ETC :

The Method of recruitment, to the said posts, age limits, qualification and other matters connected therewith shall be as specified in column 5 to 13 of the aforesaid Schedule.

(4) DISQUALIFICATION :

No person, (a) who has entered into or contracted a marriage with a person having a spouse living, or (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service, provided that, the Administrator, Daman and Diu, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

(5) POWER TO RELAX :

Where the Administrator of Daman and Diu is of the opinion that, it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

(6) SAVINGS :

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Schedule Castes and Schedule Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Must possess following minimum physical standards :

- a) Height without boots or shoes - 165 cms.
- b) Chest (Normal) 79 cms.
- c) Chest (Expanded) 84 cms.
- d) Chest (Expansion) 05 cms.
- e) Ability to run a distance of 100 meters with a load of approximately 50 kgs in a minute or 100 meters run in 12 to 13 seconds and capable of climbing a rope (**only hand**) or a vertical pipe to a height of 3 meters to 6 meters from the ground.

Must be certified to possess the visual standards specified below without glasses :

AMENDMENT

In partial modification of this Administration Order No. 27.1(iii)-EST-ADTE (Vol.3)/2013-14/270 dated 30/05/2013 on the above quated subject, the Administrator of Daman & Diu is pleased to amend Criteria/ Guidelines for Selection / Nomination of candidates against the reserved seats for Degree in Medical courses being allotted to U.T. of Daman & Diu by Government of India for the year 2013-14 at serial No. (3.vii.B) as under :-

(a) " In order to be eligible for Admission to MBBS/BDS courses for a particular academic year it shall be necessary for a candidate to obtain minimum of marks in the National Eligibility-Cum-Entrance Test (NEET) Competitive Examination as follows :-

- (i) 50th percentile Marks for General category candidates.**
- (ii) 40th percentile marks for SC/ST/OBC category candidates.**
- (iii) 45th percentile Marks for General Category Candidates with Disability/ Physical handicap."**
