Sub :- Reg. Policy guidelines for best Students & Schools for giving outstanding meritorious performance awards and trophies in Boards Exams (Class XII), "Gyan Gaurav Award".

In supersession of previous orders on the subject of award to meritorious students, the following policy is proposed to select the **Best Students & Schools** for giving meritorious performance award and trophies in the Boards based on the result of Class XII<sup>th</sup>.

This award would be known as "**Gyan Gaurav Award**".

### SCHOOL

#### 1. Categories of schools :-

- Best Higher Secondary Govt. School (U.T. Administration) in Daman District
- Best Higher Secondary Govt. School (U.T. Administration) in Diu District
- Best Higher Secondary Govt. School in the U.T. Administration of Daman and Diu.
- Best Higher Secondary School other than the U.T. Administration schools of Daman and Diu.

**2. Criteria for selection of Schools :-**

- (i) Only those schools shall be considered where at least 50 students have appeared in the respective Boards.
- (ii) Average marks obtained by each student of the school who appeared in the examination shall be considered as criteria for selection of best school in each category.
- (iii) One school shall be selected in each category.
- (iv) Formula for calculating the average marks scored by each student of a particular school shall be as under :

$$\frac{\text{Total of \% obtained by all students appeared in the concerned Board}}{\text{Total number of students appeared in the examination}}$$

In case of tie between two schools, formula of standard deviation shall be applied for deciding the best school.

**3. Award :-**

Best School in each category shall be given a trophy and a certificate from the Administrator, Daman & Diu and Dadra & Nagar Haveli.

**STUDENTS:-**

- (i) The award shall be given to the first three toppers (First, second and third position holder) of Science, Commerce, Vocational and Humanities Streams in class XII<sup>th</sup>
- (ii) The Selection will be made on the basis of maximum marks out of 500 in English and four other subjects, which are in common for the respective stream. The marks of additional elective subject preferred by the candidate shall not be considered while calculating the total marks scored by the candidate.
- (iii) The Selected students will be given an award along with the commendation certificate from the Administrator.
