### ORDER

Whereas, Administrator of Daman and Diu vide Notification No.3/50/SS(PRI)/SDP/DMN/2012-13/57 dated 17/07/2013 under Section 54 of the Daman and Diu Panchayat Regulation, 2012 (No. 4 of 2012) has constituted separate District Panchayat for the two districts of the Union Territory i.e. Daman District Panchayat for Daman district and Diu District Panchayat for Diu District.

And Whereas, vide Order No. 3/50/SS(PRI)/SDP/DMN/2012-13/59 dated 17/07/2013 President and Vice-President of erstwhile Daman and Diu District Panchayat have also ceased to hold office.

And Whereas, in pursuance of above Notification and Order of Administrator fresh election for the posts of President and Vice-President of Daman District Panchayat and Diu District Panchayat are to be conducted.

And Whereas, the Daman and Diu election of Upa-Sarpanch of a Gram Panchayat and President and Vice-President of District Panchayat Rules 2013, have been published in the Extraordinary Official Gazette No. 20 dated 20/06/2013 and have come into force on the aforesaid date.

And Whereas, Section 61 of the Daman and Diu Panchayat Regulation, 2012 (No. 4 of 2012) provides :-

- 61 (1) On the constitution of the District Panchayat for the first time under this regulation or on the expiry of the term of the District Panchayat or on its re-constitution, a meeting shall be called on a date fixed by the Secretary (Panchayat) where the elected members of the District Panchayat shall elect, from amongst themselves, a President and a Vice-President.
- (2) The officer appointed by the Secretary (Panchayat) shall preside over at such meeting, but shall not have the right to vote.
- (3) No business other than the election of the President and the Vice-President shall be transacted at such meeting.
- (4) In case of equality of votes, the result of the election shall be decided by lots drawn in the presence of the officer appointed, in such manner as he may determine.

Now, therefore, I Alka Diwan, Secretary Panchayat, Daman and Diu in exercise of powers conferred by Section 61 of the Daman and Diu Panchayat Regulation, 2012 hereby order to convene the meeting of Daman District Panchayat on 27/07/2013 at 3.00 P.M. at office of the District Panchayat at Daman to elect the President and Vice-President, Daman District Panchayat under aforesaid provisions of the Regulation and Rules. I further nominate Shri Prashant Kumar, RDC, Silvassa to preside over the said meeting on 27/07/2013 at 3.00 P.M. at District Panchayat Office, Daman.

And Whereas, the Daman and Diu Election of Upa-Sarpanch of a Gram Panchayat and President and Vice-President of District Panchayat Rules 2013, have been published in the Extraordinary Official Gazette No. 20 dated 20/06/2013 and have come into force on the aforesaid date.

And Whereas, Section 61 of the Daman and Diu Panchayat Regulation, 2012 (No. 4 of 2012) provides :-

- 61 (1) On the constitution of the District Panchayat for the first time under this Regulation or on the expiry of the term of the District Panchayat or on its reconstitution, a meeting shall be called on a date fixed by the Secretary Panchayat where the elected members of the District Panchayat shall elect, from amongst themselves, a President and a Vice-President.
- (2) The officer appointed by the Secretary (Panchayat) shall preside over at such meeting, but shall not have the right to vote.

- (3) No business other than the election of the President and the Vice-President shall be transacted at such meeting.
- (4) In case of equality of votes, the result of the election shall be decided by lots drawn in the presence of the officer appointed, in such manner as he may determine.

Now, therefore, I Alka Diwan, Secretary Panchayat, Daman and Diu in exercise of powers conferred by Section 61 of the Daman and Diu Panchayat Regulation, 2012 hereby order to convene the Meeting of Diu District Panchayat on 27/07/2013 at 3.00 P.M. at office of the District Panchayat at Diu to elect the President and Vice-President, Diu District Panchayat under the aforesaid provisions of the Regulation and Rules. I further nominate Shri R. K. Lalwatt, Director, Social Welfare, Dadra & Nagar Haveli, Silvassa to preside over the said meeting on 27/07/2013 at 3.00 P.M. at District Panchayat Office, Diu.
