Sir.

The Ministry of Social Justice & Empowerment is implementing the Centrally Sponsored Scheme of Pre-Matric Scholarship to OBC Students since 1998-99 to promote their educational development at pre-matriculation stages. Under the Scheme, the Government of India provides 50% Central Assistance to States and 100% to the UTs over and above their committed liability. Complete details of the scheme are available on Ministry's website socialjustice.nic.in/schemespro.php

- It is pertinent to mention here that the Committed Liability in 2012-13 is the total expenditure incurred by the State/UTs in 2011-12, which is terminal year of the 11th Five Year Plan under above scheme (i.e expenditure towards 50% Central Share, 50% State Share and State's Committed Liability of 2011-12). However, the North Eastern States including Sikkim are exempted from the concept of the Committed Liability.
- While furnishing the proposal for 2012-13 the State Government is required to furnish following information/documents:

- Confirmation of budget provision to meet the committed liability and State share in the State budget for 2012-13.

 (ii) The proposal should be submitted in the prescribed proformae at Annexure-III A& III B.

 (iii) The Audited Accounts and Utilization Certificate(s) for previous year grants, pending if any, are to be furnished alongwith expenditure incurred during 2011-12 in the proforma. proforma (Annexure-I) failing which it would be difficult to release the due Central Assistance. The District-wise/institution-wise data on the no. of Scholarships awarded so far under the scheme, year wise, may be sent along with proposal for 2012-13.
 - In case the State/UT Governments have a similar scheme, they may not use the Central Assistance to supplement the State Plan Scheme. The Centrally Sponsored Scheme must be implemented strictly as per the norms of the centrally sponsored scheme, while the existing State Plan scheme may be continued as separate entity. However, details of State Plan Scholarship schemes, if any, may be furnished as per Annexure-II. In case the State/UT is not implementing the Centrally Sponsored Scheme, the same may be intimated stating the reasons for non-implementation.
