NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with Government of India, Ministry of Home Affairs Order No. 7/1/65-Estt.(A) dated 16th Feb, 1965 and the Department of Personnel & Training New Delhi O.M. No.AB.14017/61/2008-Estt. (RR), dated 17th March, 2016, the Administrator of Dadra & Nagar Haveli and Daman & Diu is pleased to make the following rules relating to recruitment of Group "B" (Gazetted, Non-Ministerial) post of Child Development Project Officer, in the Administration of Dadra & Nagar Haveli & Daman & Diu namely:

(1) Short title and commencement:

- (i) These rules may be called the Administration Dadra & Nagar Haveli and Daman and Diu, Child Development Project Officer; Group 'B' (Gazetted, Non-Ministerial) posts Recruitment Rules, 2021.
- (ii) These rules shall apply to the posts specified in column-1 of the schedule to these rules.
- (iii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to various posts made on or after this date.

(2) Number of Posts, Classification and Level of Pay Matrix:

The number of posts, the classification and the level of pay matrix attached thereto shall be as specified in column 2 to 4 of the Schedule annexed to these rules: Provided that, the Administrator of Dadra & Nagar Haveli & Daman & Diu may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

(3) Method of Recruitment, Age limit and other qualification etc:

Method of Recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in column 5 to 13 of the said schedule.

(4) Disqualification:

No person (a) who has entered into or contracted a marriage with a person having a spouse living, or (b) who, having spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service provided, that the Administration of Dadra & Nagar Haveli & Daman & Diu may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other ground for so doing exempt any person from the operation of this rule.

(5) Power to relax:

Where the Administrator is of the opinion that, it is necessary or expedient, so to do, it may by order and for the reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

(6) Saving:

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes, Other Backward Class, Ex-Servicemen and other special categories of person in accordance with the order issued by the Central Government from time to time in this regard.
